



# Notice of temporary traffic lights on Crackley Lane, Kenilworth

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

## The work we will be doing

We will be constructing a plant crossing at Crackley Lane.

We will need to install two-way temporary traffic lights, to ensure a safe working area while we carry out the works. These will be removed once the works are complete.

The plant crossing will remain in place until the end of 2024 to allow our construction works to operate without impacting local journey times in the area.

## When will these works be taking place?

Two-way temporary traffic lights will be in place on **Crackley Lane** on **3 January 2023 24/7**. Our working hours will be 8am to 6pm Monday to Friday and possibly 8am to 1pm on Saturday.

## Access to all properties will be maintained.

Our workforce maybe on site one hour before and one hour after to set up and secure our equipment.

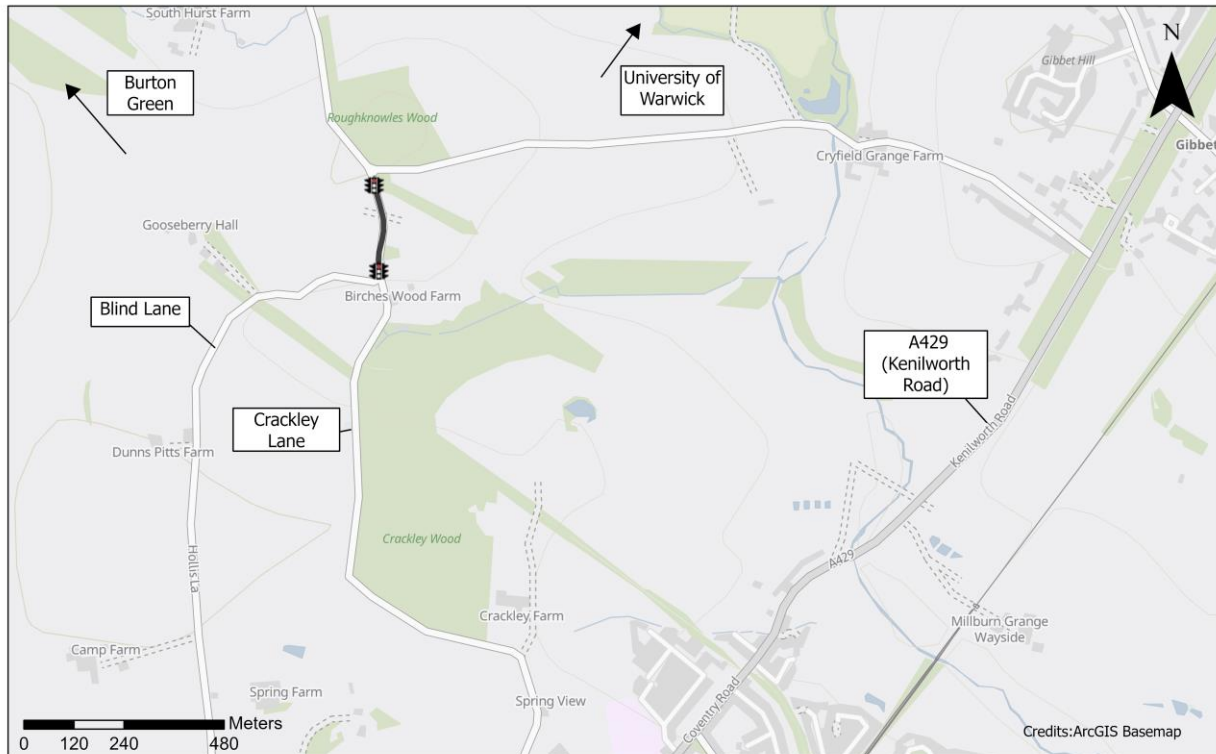
