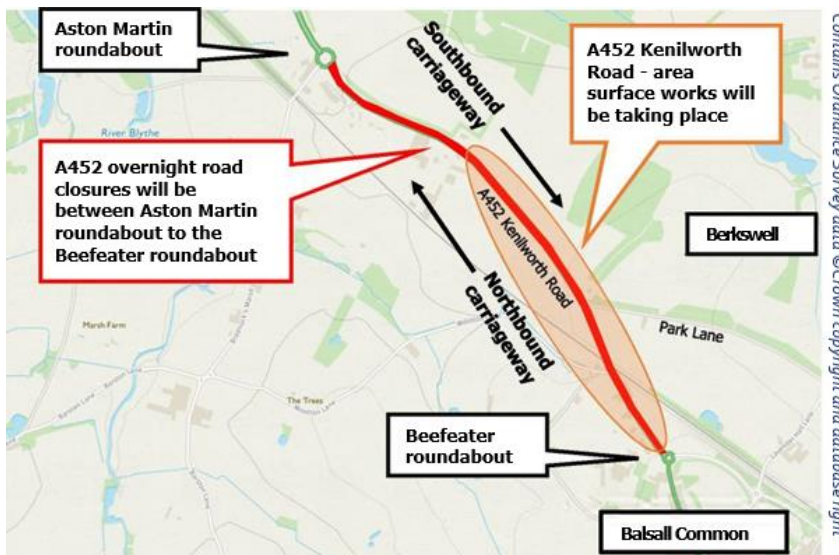
High Speed Two (HS2) is the new high-speed railway for Britain. Initial works have now started and are carried out by LM – a joint venture between Laing O'Rourke and J. Murphy & Sons.

Lane and overnight closures A452 Kenilworth Road

Surfacing and planting work is required at the new roundabout scheme at Park Lane along the A452, Berkswell. To carry out these works safely, a lane closure will be in place along the A452 southbound from Monday 9 January to Friday 13 January and northbound Monday 16 January to Friday 20 January. There will be a full overnight closure of the northbound carriageway from 8pm on Wednesday 25 January to 6am on Thursday 26 January and 8pm on Thursday 26 January to 6am on Friday 27 January.

Please check signage on the road as dates may change. All work is subject to consent, site and weather conditions.

Diversions will be clearly signposted. Access for residents and businesses within the closure area will be maintained. **For live up-to-date traffic information and diversion routes please go to one.network.** Any changes will be published on the hs2insolihull website.

Duration of works

Monday 9 Jan to Friday 13 Jan 2023, closure of lane one southbound

Monday 16 Jan to Friday 20 Jan 2023, closure of lane one northbound

Wednesday 25 Jan and Thursday 26 Jan 2023 overnight 8pm to 6am full closure northbound. Diversions in place.

Working hours

Overnight closures start at 8pm and finish at 6am each day. Our contractors may also be on site for up to one hour beforehand and after to set up and pack up the site.
