



Notice of M42 M6 eastbound link road overnight closure and diversion on 27 January 2023

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be completing

These works are subject to consent. To assist our ongoing construction activities for the M42 M6 link road Viaducts, we will carry out CCTV surveys and carriageway cleaning along the eastbound link road on Friday 27 January 2023. The cleaning programme will be in addition to the daily mitigation measures we have in place and will ensure the impact of our working operations on the highway is reduced as much as possible.

To complete these works safely, we will install an overnight closure on the M42 M6 link road eastbound on Friday 27 January 2023. The closure will be in place from 9.00pm on Friday night until 5.00am on Saturday morning. Our contractors may be on site up to an hour before and after these times to set up and close down the site.

Throughout this closure a clear diversion route will be installed. The diversion will follow the M6 southbound until junction 4, via the A446 and A452 southbound. Following this, road users will be able to follow the A45 westbound to the M42. The location of the road closure and diversion is shown on the map on page 2.

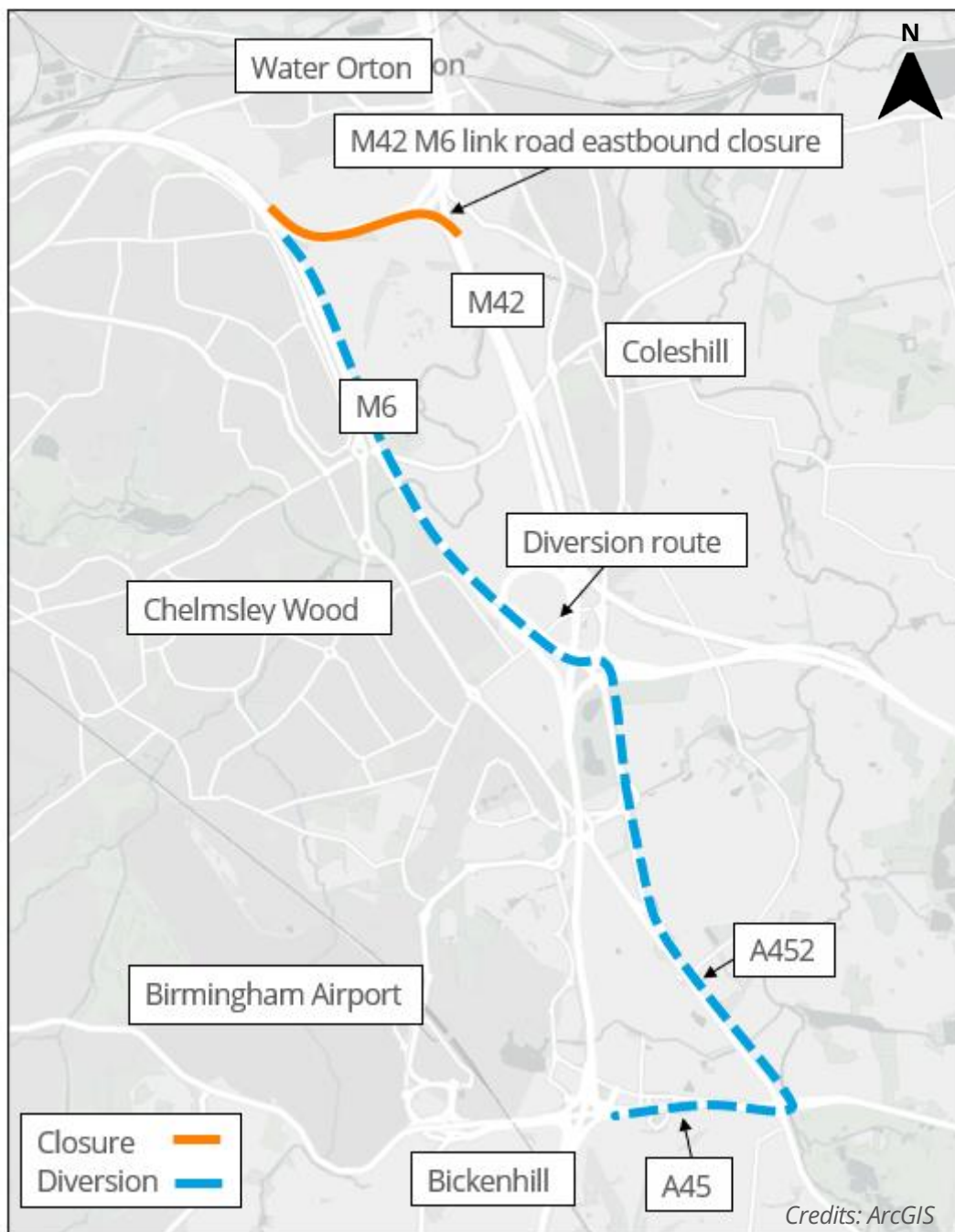

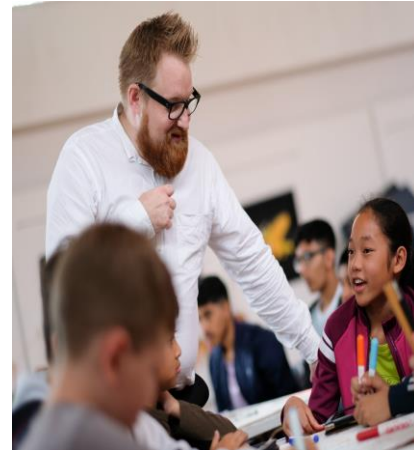
About our Community and Business Funds
