



Notice of Lane Closure on Northway Island

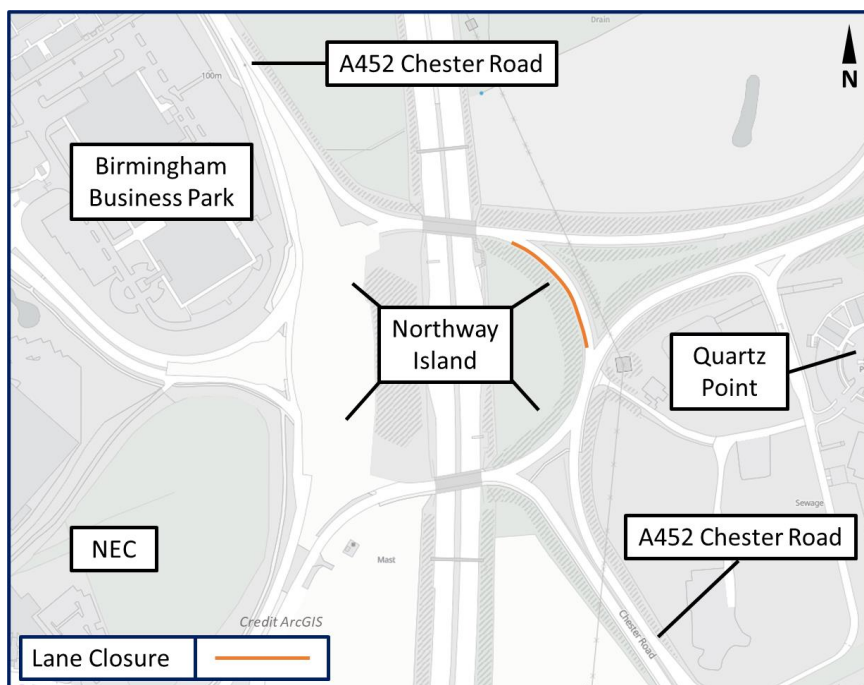

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To build the new railway, the A452 Chester Road between the A446 and the Northway Island is being significantly remodelled. As part of this work we will be constructing a new roundabout opposite Quartz Point to serve the slip roads onto the A446. To gain safe access to the site of the new roundabout, we will need to close a lane on the roundabout from 9 January to 9 September 2023. The lane closure will be in place all day, every day until the new roundabout is complete.
