### Notice of road closure programme update, Quainton

High Speed Two (HS2) is the new high speed railway for Britain. If you have any questions or enquiries about our work, please contact our Helpdesk to find out more. You can sign up for regular updates in your local area at www.hs2inbucksandox.co.uk.

#### What are we doing?

In February 2023, we will be carrying out road repairs and improvements on a section of Quainton Road from the crossroads towards Waddesdon. This closure has been scheduled to avoid an overlap with the road resurfacing works on the southern section of Station Road.

We will be improving this section of Quainton Road by installing new roadside curb stones and resurfacing the road.

As our teams will be carrying out these works on and next to the carriage way, this section of road will be closed for approximately two weeks.

#### When will these works take place?

A section of Quainton Road will be closed 24-hours a day from Monday 6 February to Saturday 18 February.

There will be no access at all through this section of road during this period.

These dates may change due to conditions outside of our control. Please refer to the HS2 website regularly to check for any changes and updates.

Take care to respect the community.




