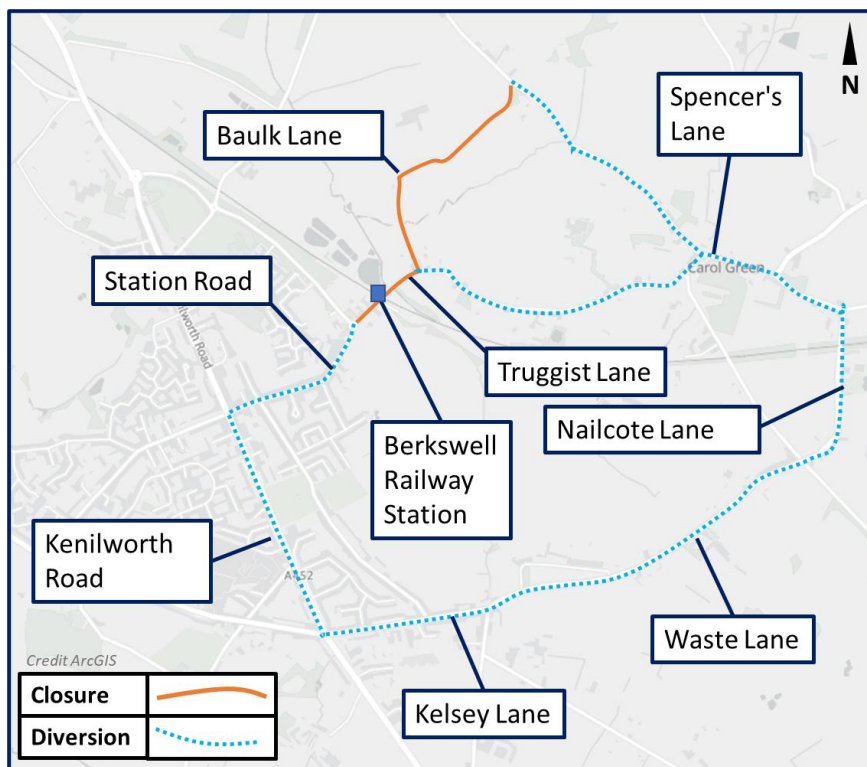
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

## The work we will be doing

BBV will be installing a new traffic light system on Truggist Lane to manage the flow of traffic under the low bridge and at our plant crossing. This new system will allow us to manage the traffic more intelligently and minimise risk of an outage.

To do this work safely, we will need to close Truggist Lane and Baulk Lane on 12 and 13 January 2023 between 9:30am and 3:30pm. A fully signed diversion will be in place via Kelsey Lane, Waste Lane and Spencer's Lane. Please see the map below.
