High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

To progress HS2 works, we will be carrying out utility diversion works at Rugby Road from 9 January 2023 to 3 February 2023.

Road closure will be required to ensure the works can be carried out safely.

When will these works be taking place?

A section of Rugby Road will be closed from 9 January 2023 to 3 **February 2023** to minimize disruption to peak traffic. A fully signed diversion will be in place during this closure. (Please see map below).

Access to all properties including businesses will be maintained throughout via the Weston under Wetherley side of the closure.

Our workforce maybe on site one hour before and one hour after to set up and secure our equipment.


