
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

# The work we will be doing

In order for BBV to construct the remaining parking bays on Hallmeadow Road, National Grid Electricity Distribution (NGED), the company responsible for the electricity distribution network will need to divert a power cable. To do this safely BBV will close the southbound lane opposite the junction with Riddings Hill and Ashley Drive leading to the Health Centre. Access will be maintained using four-way traffic lights placed either end of the closure and on Riddings Hill and Ashley Drive

# When will the work take place

You may be aware that unless there is an exceptional circumstance, HS2 works only take place between the hours of 8am and 6pm Monday-Friday, 8am -1 pm on Saturdays and not at all on Sundays and Bank Holidays. As this work falls outside of the area covered by the HS2 Act and is being undertaken by NGED they may choose to work outside of these hours.
