



# Notice of overnight closure of M42 Junction 7a link road to M6

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

## The work we will be doing

The new railway will travel over the M6 and M42 loop on a series of bridges and viaduct structures. To protect road users from our construction activities we need to extend the temporary safety barriers on the Loop section of Junction 7a of the M42 that connects the northbound carriageway with the southbound carriageway of the M6. To do this safely we will need to close this section for one night. Traffic will be directed north to Junction 8 of the M42 before returning down the southbound carriageway to exit at Junction 7 as normal. The temporary safety barrier will remain in the hard shoulder to protect the works behind it.

The 'loop' section will be closed at 9pm on Sunday 8 January and will re-open at 5am on Monday 9 January.

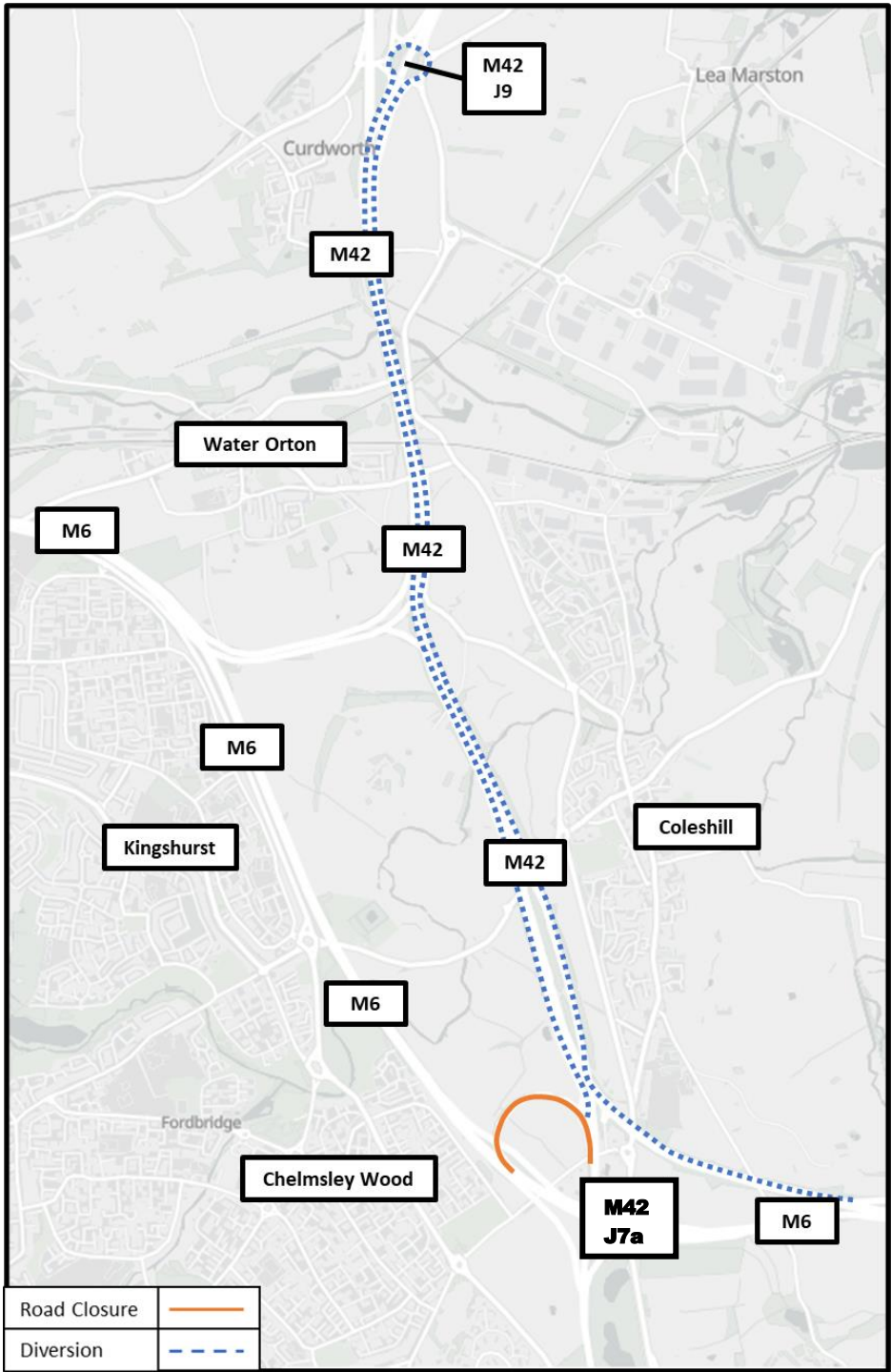
