Notice of traffic management update, Blackgrove Road

High Speed Two (HS2) is the new high speed railway for Britain. If you have any questions or enquiries about our work, please contact our Helpdesk to find out more. You can sign up for regular updates in your local area at www.hs2inyourarea.co.uk.

What are we doing?

We will be carrying out BT and Thames Water utility diversion works along Blackgrove Road. The Utility teams will be working on diverting the existing connections and farm access works. We are required to conduct this work ahead of the A41 realignment works due to commence in the new year.

As we are working around the carriageway, we will need to implement traffic lights for road users.

In addition to the utility works, we will also be conducting some localised vegetation clearance which will allow us to clear the area needed to construct the new A41 alignment.

When will these works take place?

Traffic management will be on Blackgrove Road from Monday 27 February 2023 to Summer 2023 from 9am to 5pm. During these times, a section of Blackgrove Road near our works area will have temporary traffic lights in use.

Unfortunately, this work has taken longer than anticipated due to conditions outside of our control but we will endeavour to complete the works within the specified times.

Single lane closures and temporary traffic lights.

Varied activities with both quiet and busier periods.

Noise from plant and equipment used for the works.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

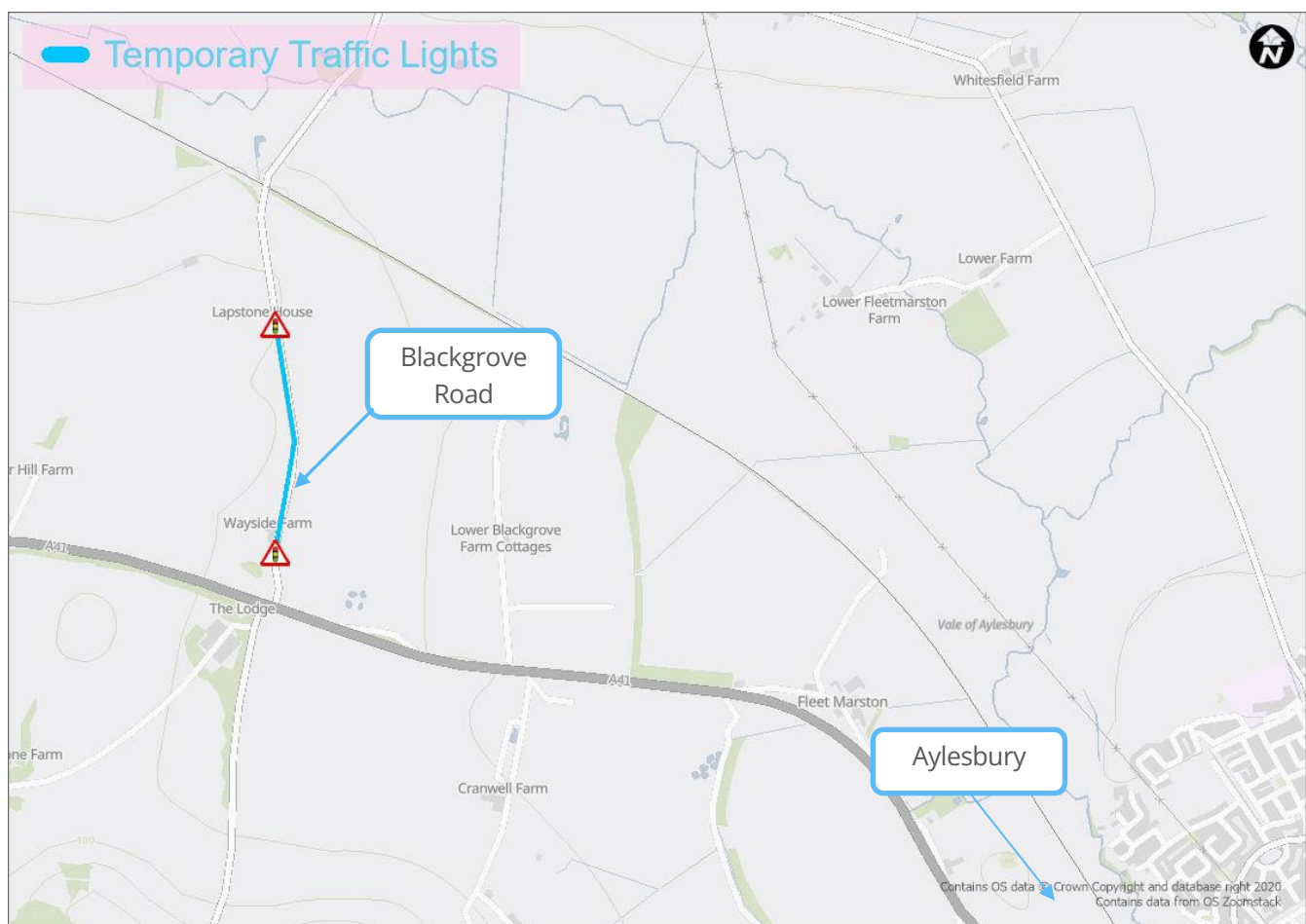
