High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

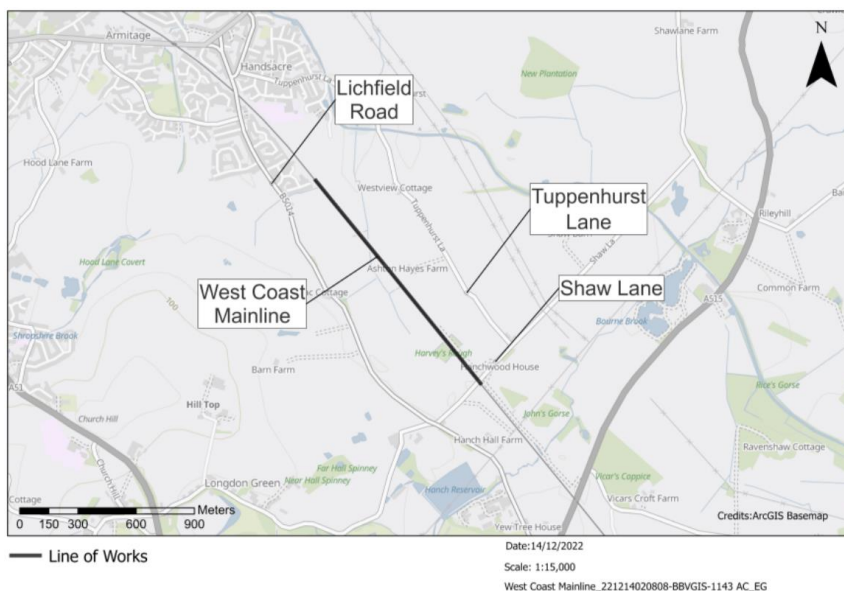
The work we are doing

We are working with Network Rail to plan and deliver preparatory works on the West Coast Mainline. We will be undertaking survey works to gather information on the existing West Coast Mainline and will use a range of tools, survey equipment and lighting.

When the works will take place

As this is one of the UK's busiest rail routes the works will be undertaken overnight each Saturday between 14 January 2023 to 4 March 2023. The works will take place between the hours of 10pm each Saturday night to 9am each Sunday morning.
