Update: Stanhope Street closure and works on Park Village East

High Speed Two (HS2) is the new high speed railway for Britain.

Stanhope Street closed - 2 February to April

In December, we informed you we are installing a new cable route from Lidlington Place to Varndell Street via Granby Terrace, to replace the existing route next to Hampstead Road.

On 2 February, we will begin works on Stanhope Street. We will excavate a trench within the carriageway and install cable ducts, before filling in the trench and reinstating the road. We expect to complete these works by April.

We will close the road and suspend parking on the corner of Stanhope Street and Park Village East. We will also close the section of the footway next to our worksite and pedestrians will be diverted to the opposite footway. Traffic will be diverted via Augustus Street, Cumberland Market, and Varndell Street. Please refer to the map on the next page.

Once this work is complete, we will move on to the next phases on Stanhope Street and Varndell Street. We will provide more information about the traffic management closer to the time.

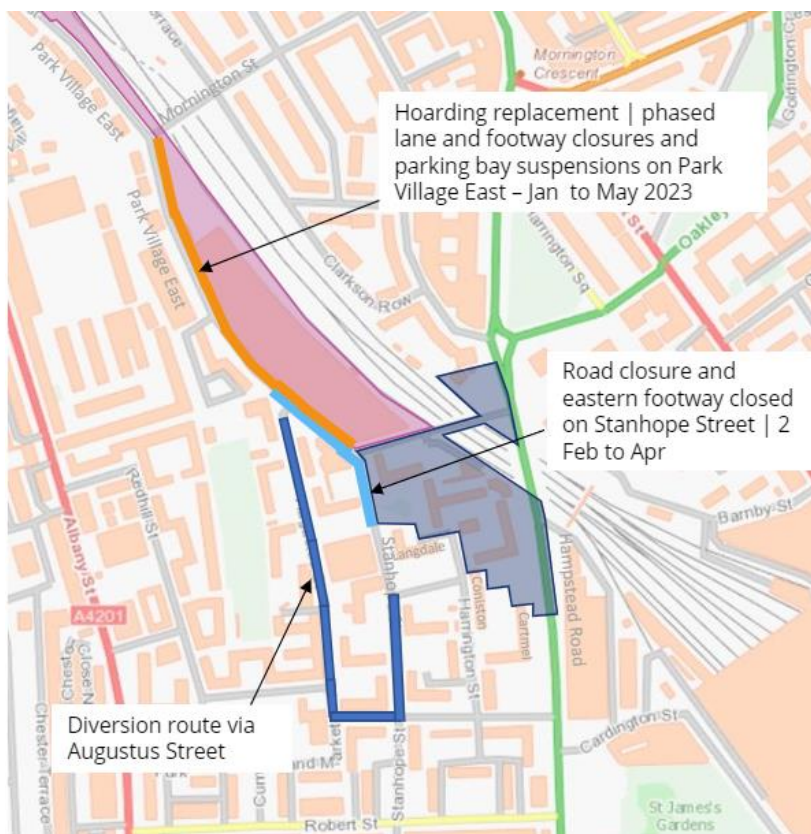

Hoarding replacement on Park Village East (south) - January to May

We previously informed you we need to replace the hoarding at the southern end of Park Village East. We have now started installing the traffic management for these works.

We will replace the hoarding in sections, working our way along Park Village East from Stanhope Street towards Mornington Street bridge. These works will require rolling footpath and lane closures and intermittent parking bay suspensions. The artwork will remain unchanged.

We will use traffic lights to control the traffic and expect the new hoarding to take about 16 weeks to install. The hoarding will remain in place until the completion of HS2 works in this area.
