
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be completing

The Curdworth Box will carry the HS2 trainline over the existing trainline, to the east of the A446 in Coleshill. As part of the works for the Curdworth Box, piling activities will recommence in January 2023.

The bored piling will continue from Monday 3 January 2023 until the end of February 2023. Bored piles are used to form a foundation that provides support for structures by distributing their weight evenly across the ground. To install the piles, we will use a piling machine to drill a vertical hole deep into the ground. We will then lower the reinforced steel into the hole using a crane before filling the hole with concrete.

Our working hours will be from 7.30am until 7.00pm, Monday to Friday. The location of the areas we will be working in are outlined in the map below.



Duration of works

- Continued piling works to take place throughout January 2023 and February 2023 for **Curdworth Box**
- Our working hours will be from 7.30am until 7.00pm Monday – Friday

What to expect

- Extended working hours near Faraday Avenue for piling activity to continue through January 2023 and February 2023
- Our contractors may be on site up to an hour before and after these times to set up and close down our sites.
