High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Upcoming Utility Diversions

We will be carrying out a series of overnight utility diversions along High Street, Saltley Viaduct, Adderley Road, Cranby Street and Crawford Street. For the team to work safely in the road, from Monday 16 January for approximately 12 weeks, Saltley Viaduct will be closed overnight. To carry out this work we will need to excavate sections of the roads and relocate various utilities before then resurfacing the excavated section.

Overnight Road Closure

The closures will be in place overnight between 10.00pm and 6.00am from Monday 16 January for approximately 12 weeks. Aston Church Road will be used as the main diversion route for all traffic including buses during this period.

Access to properties and businesses will be maintained throughout.

Monday 16 January for approximately 12 weeks.

Road Closure operational 10.00pm – 6.00am.

Our workforce may be on site up to 1 hour before work begins to set up the site and again afterwards to take down our work equipment.

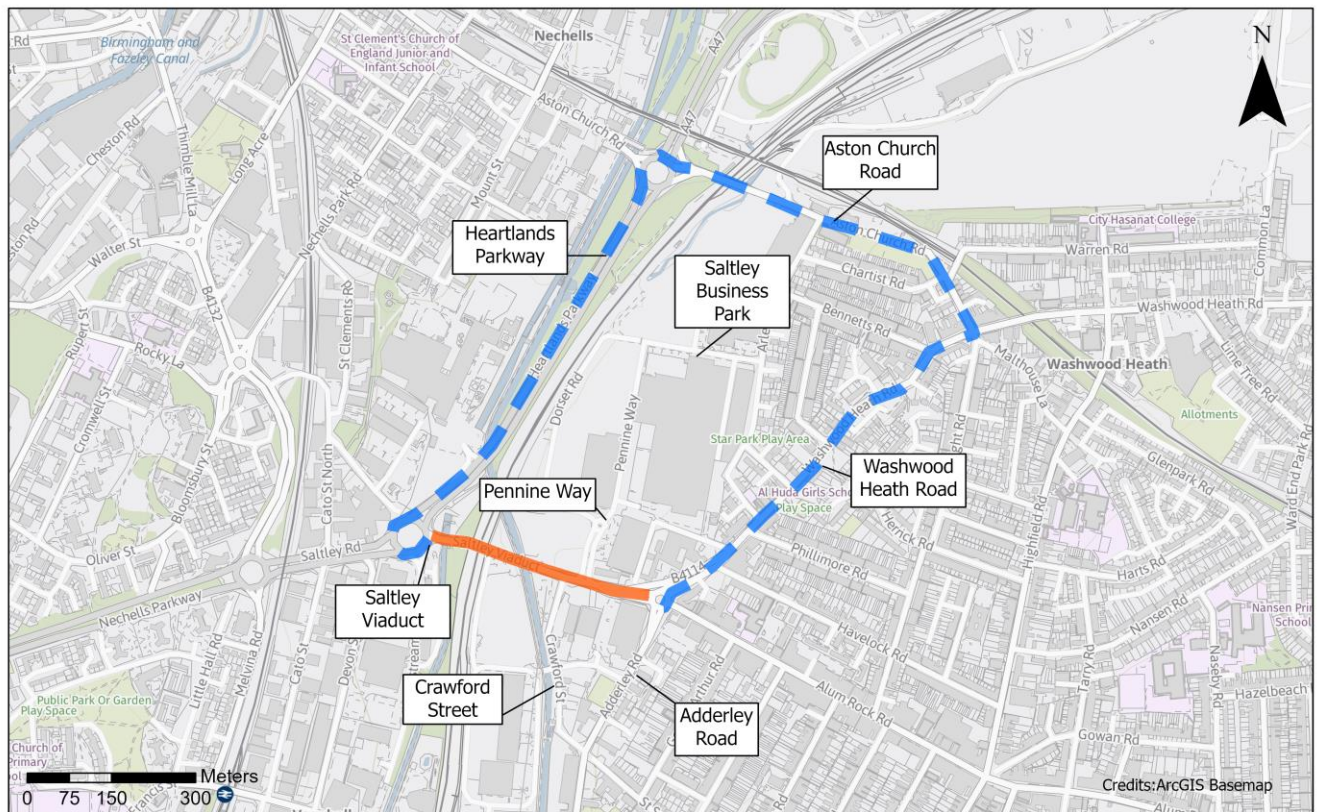

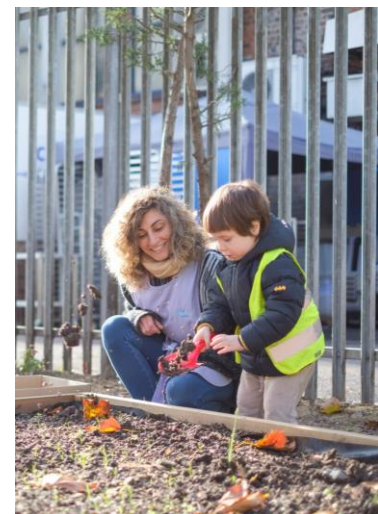
About our Community and Business Funds
