

Notice of Road closure on the A34 and the A51, Stone bypass

High Speed Two (HS2) is the new high speed railway for Britain. Kier is carrying out surveys and investigating ground conditions along the Phase 2a route.

What we are doing

We previously carried out ground penetrating radar and topographical surveys which are above ground. Our next step is carrying out surveys to help us inform future construction design. This work involves pavement coring, bore holes, trial pits on and off the highway. We will excavate below ground to provide us with samples and allow us to view the structure and record the layout of land.

To carry out this work safely we will need to close the A34 Southbound and the A51 leading off the Aston roundabout.

When the work will take place

This work will take place from **Monday 9 January to Tuesday 31 January 2023 9pm to 5am**. (excluding weekends) The work will start on the A34 before moving on to the A51 and will not take place at the same time. Please note that all our planned roadworks may be subject to change due to weather conditions or unforeseen circumstances.

How will this affect you

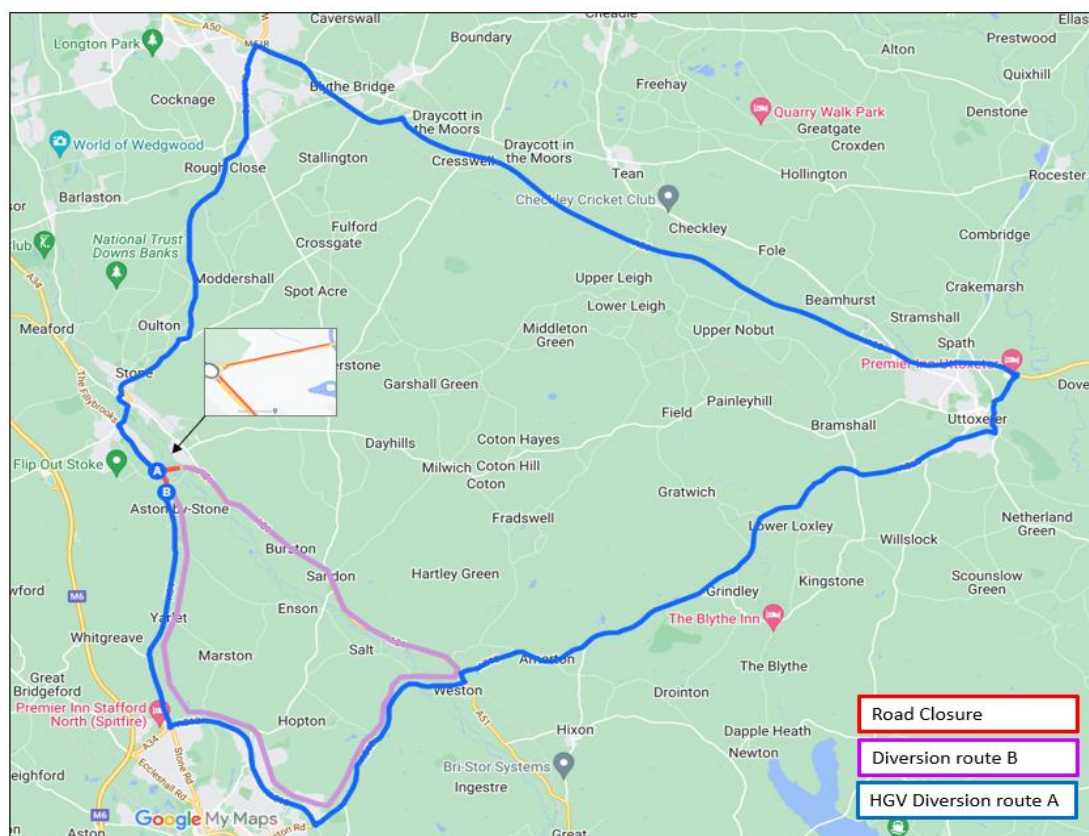
Because of a low bridge on the A51, there will be a separate diversion route for HGV's when the closures are in place. These have been chosen as the most suitable for vehicle requirements by Staffordshire County Council. During this time HGVs will need to allow approximately 40 minutes for your journey and 20 minutes for cars and other vehicles. We will put a signed diversion route in place on the evenings of the road closures.

As part of the work, we will use machinery and equipment that may generate some noise throughout our time on site, we will work to reduce the impact on properties.

How we will minimise disruption

We recognise this maybe be frustrating and by working overnight this is the safest and least disruptive way of completing our survey work. We will maintain access for properties and business within the traffic management area. Please be patient while we secure the work area to guide users in and out safely. We will also carry out the following:

Reduce noise generated from our vehicles when not in use. Obtain permission from Staffordshire County Council to avoid clashes with other roadworks in the area to prevent delays. Restore work areas to their original condition and work hard to complete the work safely and as quickly as possible.

About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
