



Notice of Emergency Road Closure – A452 Southbound

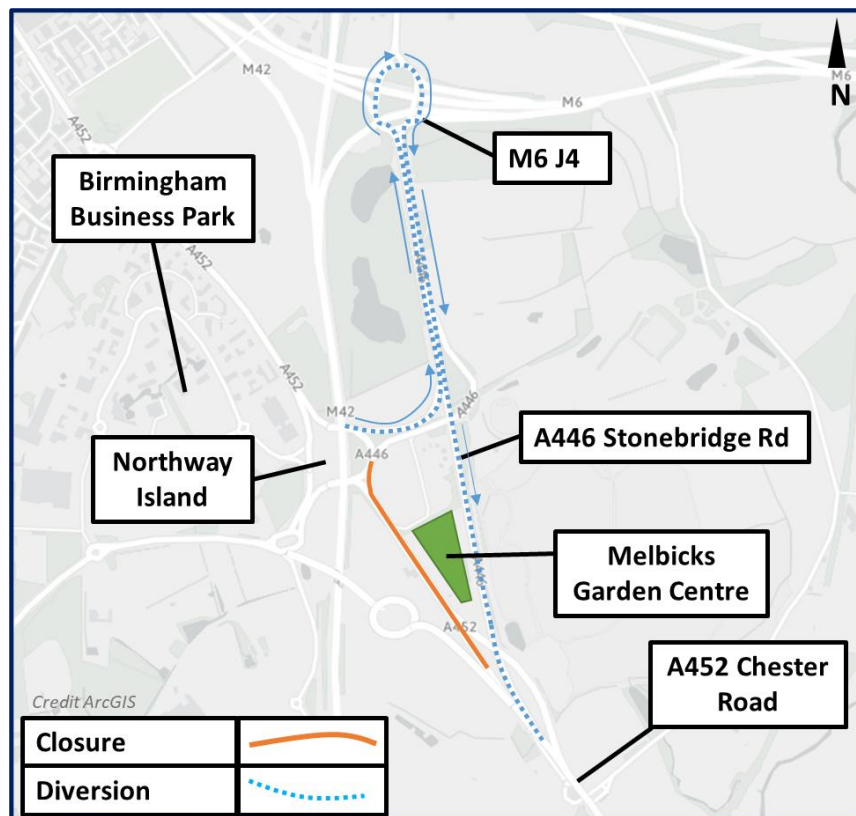

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

The work we will be doing

BBV will need to close the southbound carriageway of the A452 for one night in order to repair a safety barrier that was damaged over the weekend. We will close the road from Northway Island to the junction with the A446, the part of the road that runs adjacent to Melbicks garden centre. The road will close at 9pm on 1 February and although it is scheduled to reopen at 5am on 2 February, it will reopen when the work is complete which may be much sooner.

For one night between 9pm on 1 February until 5am on 2 February.
