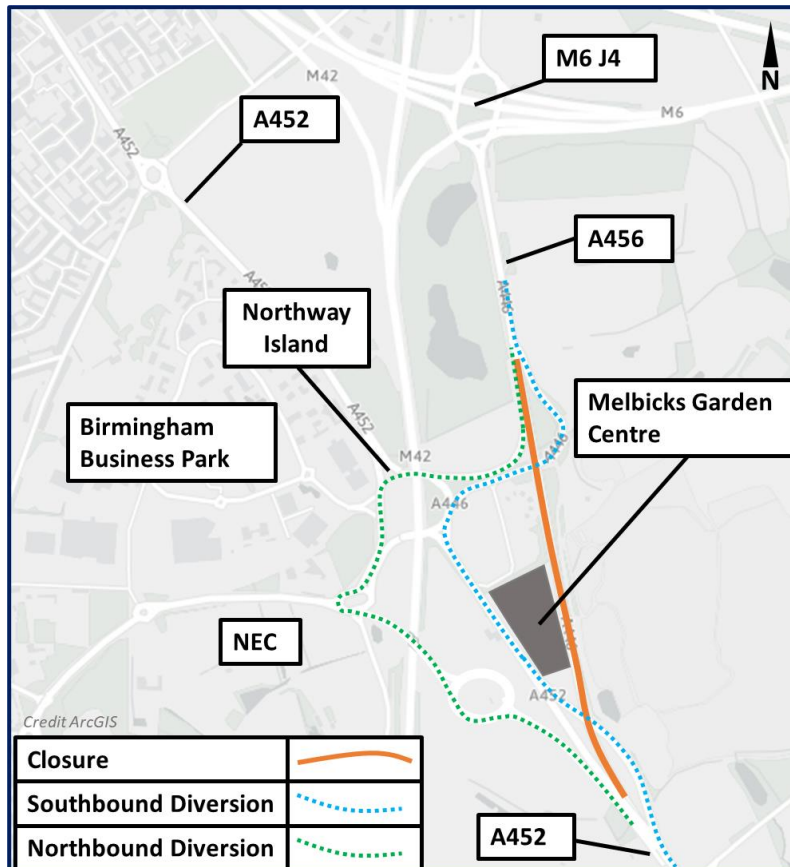

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

The work we will be doing

BBV have been significantly reconfiguring the Junction of the A446 Stonebridge Road and A452 Chester Road near Birmingham Business Park. As part of this work, a new bridge has been built over the A452 which requires a routine safety inspection. To do this safely, both carriageways of the A446 will need to close overnight on Monday 13 February between 9pm and 5am. Traffic in both directions will be diverted via Northway Island and our new bridge over the M42. (Please see the map below).
