



# Notice of Road Closures at Coleshill Heath Road



High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

## The work we will be doing

The new railway will be elevated on an embankment as it passes over Colehill Heath Road. To ensure that our work does not affect the supply, a number of exiting utilities will need to be diverted. In order to do this safely Coleshill Heath Road adjacent to Heath Park will be closed overnight from 8pm until 6am on Monday 13 February until Saturday 1 April. Traffic will be diverted via Chester Road, over the motorways on Birmingham Road then back down Stonebridge Road towards Junction 4 of the M6. (See map overleaf) Pedestrian access will be maintained.

13 February until 1 April, overnight between 8pm and 6am

## What to expect

Low level noise from our work.

Fully signed diversion
