High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We will be working along Shaw Lane to clear vegetation and undertake trial hole surveys. The surveys are being undertaken to progress the design of the utilities that need to be diverted at this location.

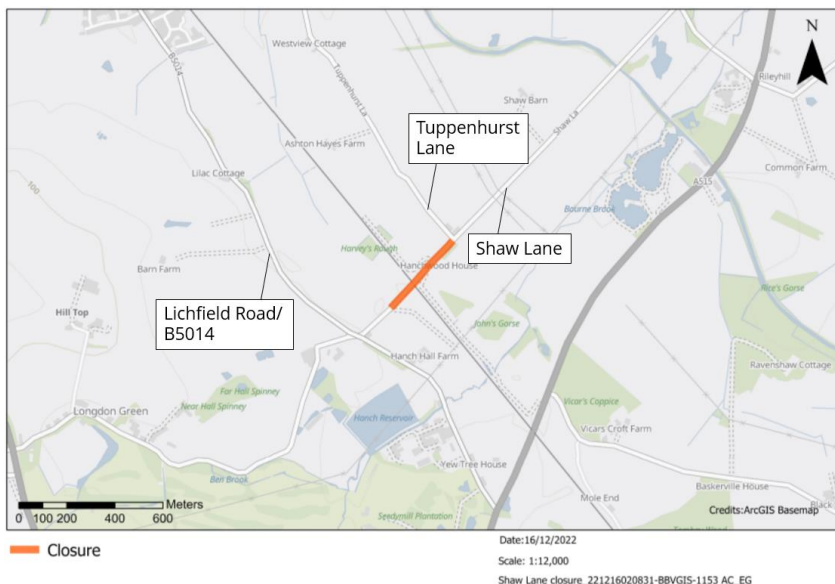
When the work will take place

The works will take place from Monday 30 January to Friday 3 February 2023. To carry out these works safely we will install a temporary closure of Shaw Lane. The closure will be in place from 9.30am to 3.30pm each day.

Access to properties along Shaw Lane will be maintained.
