High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

### The work we will be doing

We will be undertaking trial hole and coring surveys on Wood End Lane. These surveys will be undertaken on the carriageway and verges at this location (please see map below of our working area). The surveys are being undertaken to progress the design of the new alignment of Wood End Lane. The works will also include vegetation clearance along the verges.

### When the work will take place

The works will take place from Monday 30 January to Friday 3 February 2023. To carry out these works safely we will install temporary traffic lights on Wood End Lane from 9:30am to 3:30pm each day.

### Where we will be working

### Duration of works

One week of temporary daytime traffic lights from Monday 30 January to Friday 3 February 2023

Our traffic lights and working hours will be from 9:30am until 3:30pm each day

Low-level of noise from our machinery

Our workforce may be on-site up to one hour before and after to set up and secure our equipment
