

Notice of investigation works for water main diversion – A34 Stone Road

Notification

High Speed Two (HS2) is the new high speed railway for Britain. To allow for the construction of the new railway and to continue to ensure a safe and reliable water supply, Severn Trent Water will be commencing survey works in January 2023.

What are we doing?

Severn Trent Water will be undertaking topographical and GPR surveys in order to carry out their potable water main diversions.

Surveys will be undertaken within the A34 Stone Road extending from Hilltop Farm to Yarlet Bank Farm

In order to carry out the work safely, single lane closure will be in place for the duration of the works.

The work is planned to take place from **Monday 13 Feb 2023 to Tuesday 14 Feb 2023.** All the works will be undertaken between 9am and 3pm.

Once our survey works have been completed, we will prepare a programme for the proposed ground investigation. We will inform you when this programme has been confirmed.

How will this affect you?

The vehicles being used for these works will be no more than 2 flatbed vans and 2 cars.

We do not anticipate **our** traffic movements **to** have any significant impact on the local road network. **However the bus stop will be suspended on Monday 13 and Tuesday 14 Feb 2023.**

The plan below shows the extent and position of the traffic management measures, which will be a single lane closure on the A34 Stone Road extending from Hilltop Farm to Yarlet Bank Farm and will total approximately 700m long.

We have designed our works to avoid disruption to the water supplies of our customers.

- Monday 13 Feb 2023 to Tuesday 14 Feb 2023.
- Our working hours will be 9am to 3pm

What to expect

- Signage on the roadside where we access our worksite.
- Traffic cones to maintain a safe working environment.
- Bus stop to be suspended.

What we will do

- Limit the amount of vehicle movements
- Make sure all survey vehicles use agreed routes
- Maintain a safe working environment
- Inform people in advance of any changes
