High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area


The work we will be doing

BBV have been significantly reconfiguring the junction of the A452 Chester Road and A446 Stonebridge Road near Birmingham Business Park. The recently completed new slip road will need to close while we do some final preparation work before opening the new roundabout. The work will include new safety barriers, paving work, new planting in the verges and painting new road markings. Traffic will be diverted up to the roundabout at Junction 4 of the M6 and back via Northway Island near Birmingham Business Park. (see map below)

When will the work take place

The road will be closed all day and all night from 8pm on Friday 10 February until 5am on Monday 13th February.

All day and all night from 8pm on Friday 10 February until 5am on Monday 13 February.

Low level noise from our work.
