# Notice of night-time closure for line marking, A361, Chipping Warden

High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. You can sign up for regular updates in your local area at [www.hs2inyourarea.co.uk](http://www.hs2inyourarea.co.uk).

## What are we doing?

In the area under the A361 temporary bridge, near Chipping Warden, we will be improving the white line marking for safety reasons.

In order to carry out this work, a full closure of a small section of the A361 will be required for several hours. This will allow staff to enter the central section of the highway and for the line marking paint to fully set.

The line painting may be affected by weather conditions and so if wet weather is forecast, the work may be postponed to the following evening. We will work as quickly as possible to re-open the road once the line marking paint is set our workforce are clear.

## When will these works take place?

A section of the A361 Byfield Road will be closed approximately 8pm - 12 midnight on Saturday 21 January.

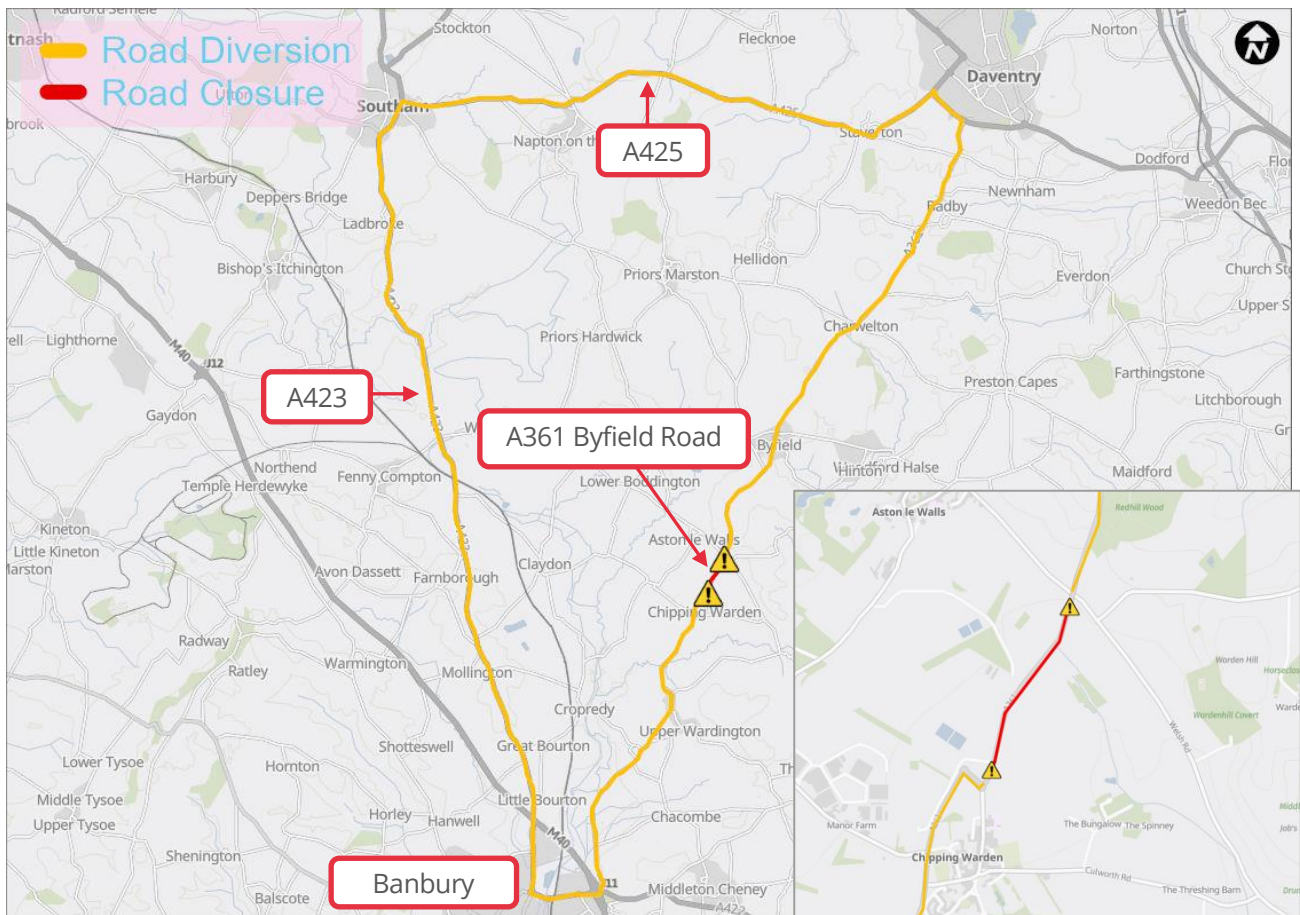
