

Notice of road closure, Helmdon Road, Greatworth

High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. The health and safety of our workforce and the communities we work within is our priority. You can sign up for regular updates in your local area at www.hs2innorthants.co.uk.

What are we doing?

As our preparations continue for the Greatworth Green tunnel, we need to remove small areas of vegetation along Helmdon Road, Greatworth. This work will take approximately 2 weeks to complete.

By carrying out this work in the winter we will minimise the risks of disturbing nesting birds. Prior to any vegetation removal, an ecologist will complete a detailed survey of the area to be cleared. Any protected species found to be present will be recorded and the vegetation will be left undisturbed with the appropriate buffer zone established.

For the safety of road users and our staff, we are required to close Helmdon Road during the day for the duration of the works.

When will these works take place?

A section of Helmdon Road will be closed during the day, 8am to 6pm, from Monday 13 February to Sunday 26 February 2023.

Working hours:

Our contractors may be on site for one hour's start-up and shutdown either side of these times.

What to expect

Varied activities with both quiet and busier periods.

The closure of a section of Helmdon Road for 2 weeks.

Noise from equipment used for the works.

Localised vegetation clearance to facilitate upcoming works.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

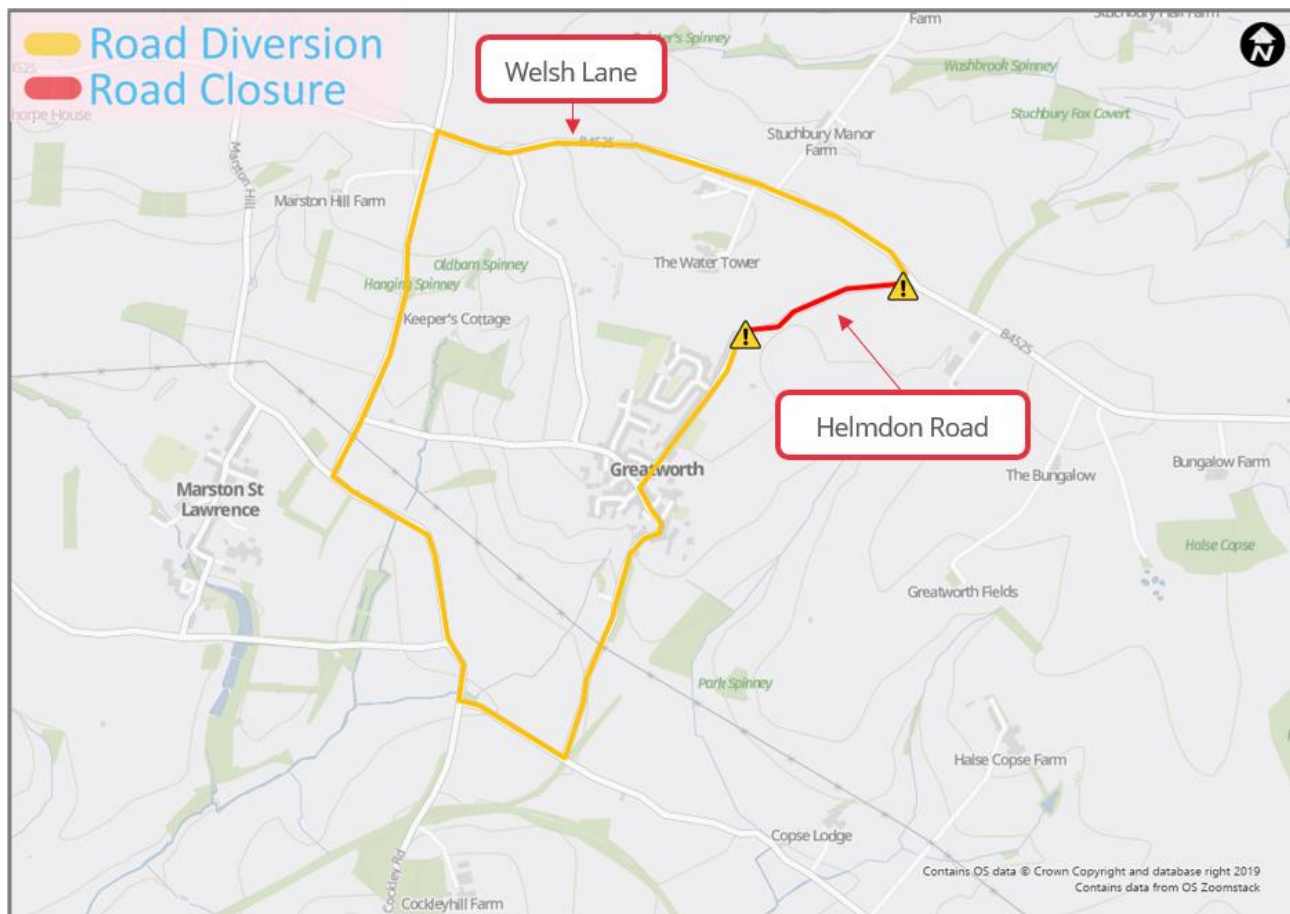
