

Notice of traffic management, A361, Chipping Warden

High Speed Two (HS2) is the new high speed railway for Britain. We are following Government and Public Health England (PHE) advice on working safely during the pandemic. The health and safety of our workforce and the communities we work within is our priority. You can sign up for regular updates in your local area at www.hs2inyourarea.co.uk.

What are we doing?

Prior to the next phase of construction on the Chipping Warden Green Tunnel, we need to accurately identify and inspect the existing utilities that are located under the A361 near to our compound entrance.

These surveys will include carrying out trial holes, as well as ground penetrating radar. The trial hole surveys involve drilling small inspection holes into the highway or verge, to identify the exact depth and condition of utility pipes and cables. The holes are then immediately backfilled once all details are recorded.

We currently have traffic lights in this location, for the safe arrival and departure of vehicles at our compound. The layout of the traffic lights will be changed for approximately two weeks, to enable the lane closures required to carry out this survey work.

When will these works take place?

A section of the A361 will have temporary traffic management in the form of traffic lights, on weekdays from Monday 23 January to Saturday 4 February 2023. This will take place during the daytime, from 8am to 6pm Mondays to Fridays, and 8am-1pm on Saturdays.

Respond promptly to any complaints and take appropriate action.

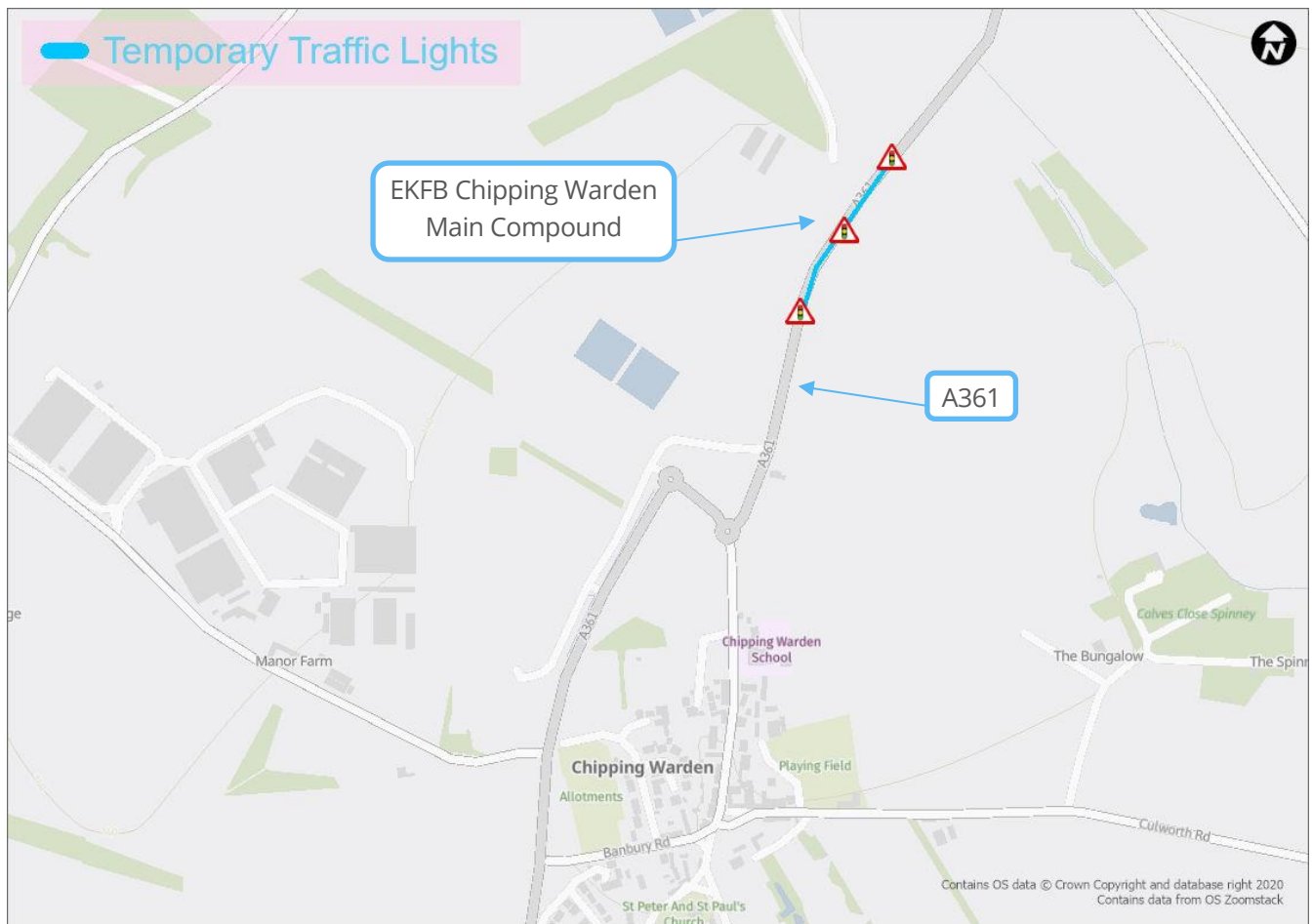
