Park Village East closure for hoarding maintenance



High Speed Two (HS2) is the new high speed railway for Britain.

Road closure in Park Village East north – 30 and 31 January

On 30 and 31 January, we will close a section of Park Village East between Parkway and Mornington Street Bridge to carry out hoarding maintenance on the lorry lay-by. The road will be closed between 8am and 6pm both days, and open in the evenings and overnight.

Traffic will be diverted via Albany Street, Robert Street and Stanhope Street. We will maintain vehicle access for local businesses and residents. Vehicles may be delayed for a few minutes while we clear the road to allow them to pass. We apologise for any inconvenience this may cause.



UK Power Networks substation install – February 2023

We previously informed you that UK Power Networks will install a substation within the lorry lay-by next to 1 Park Village East to provide power to our track-level worksite. The install will now take place from 8 February until early March.
