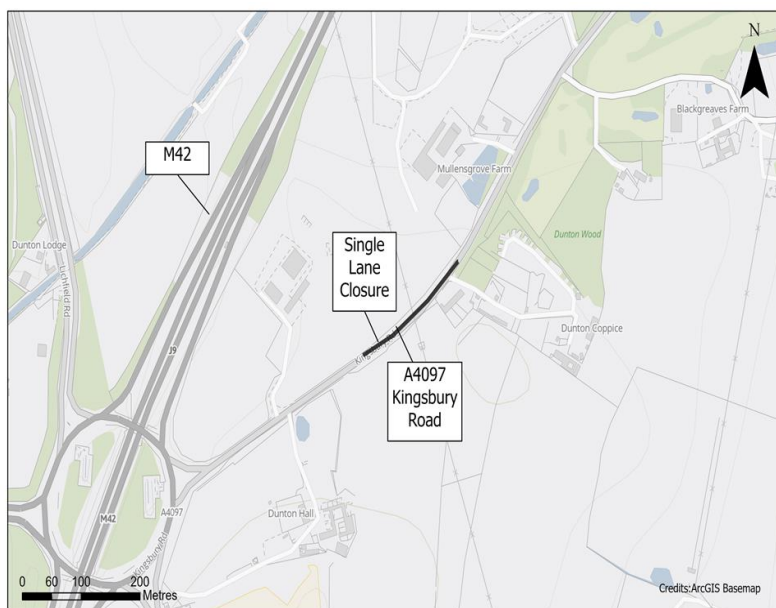
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We are creating an access to our working area off the A4097 Kingsbury Road. While completing these works we have located a concrete slab buried at this location which will need to be excavated to complete a utility diversion. To maintain the safety of road users, equestrian and pedestrians we have extended the overnight lane closure, with temporary traffic lights, for an additional week.

When the work will take place

We will complete these works from Monday 06 February to Friday 10 February 2023. Our working hours will be 8pm to 6am.
