



## Update notice of site access gate installation – Curzon Street, Birmingham

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

### Installation of new site access gate

We previously notified you that as we prepare to start working on the section of site closest to Lawley Middleway, we will need to install a new site access gate.

This work was due to complete on 5 May 2023 however due to unforeseen delays we now expect to need to continue the works until 3 September 2023.

### Road narrows and pedestrian diversion

To complete these works safely we will need to keep the road narrowing system and continue to divert pedestrians across to the opposite side of the road from our works.

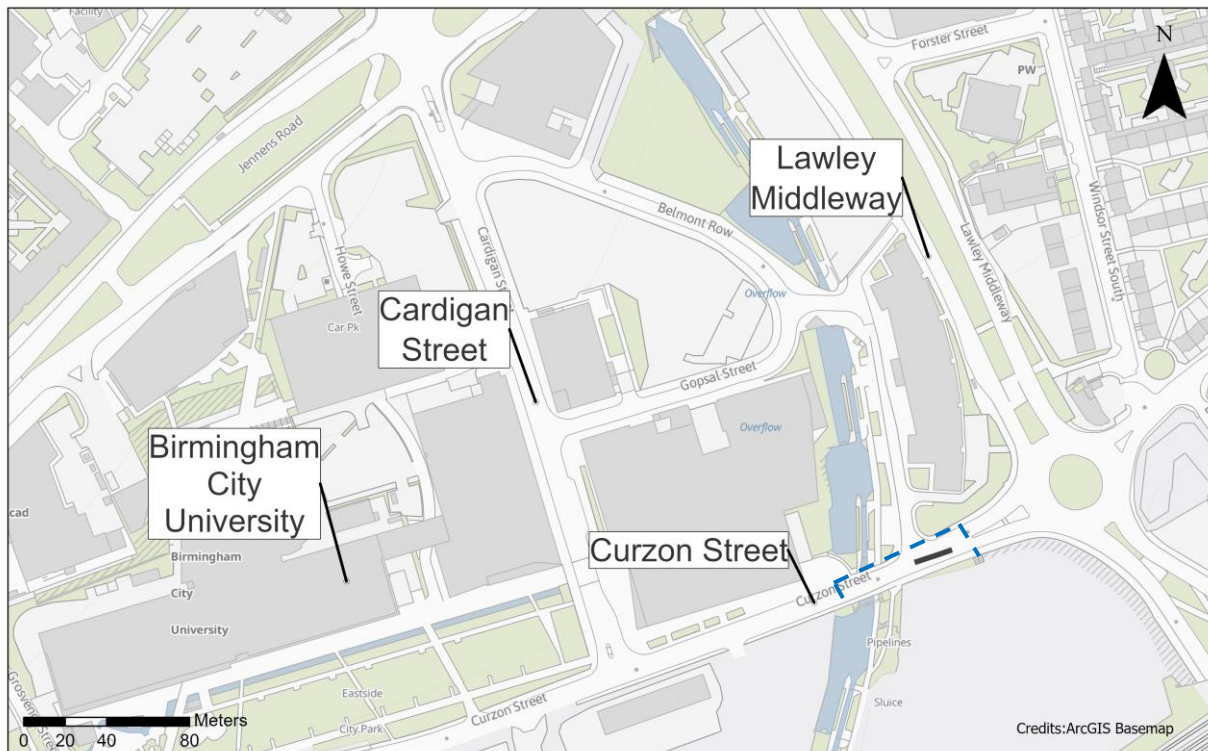
