High Speed Two (HS2) is the new high speed railway for Britain.

Ground investigations in your area

From 14 March to 31 March 2023 (Phase one), and 03 April to 14 April 2023 (Phase two) we will be carrying out a series of ground investigations on Kilburn High Road and Springfield Lane.

The ground investigations will consist of digging a temporary trench to confirm the location of utilities under the surface of the road. The investigations will help us to understand and aid the design of the new railway and the best ways to protect or divert any utilities during construction. Your utility services will not be affected during these works.

The ground investigations will take place between 8am to 6pm Monday to Friday and from 8am to 1pm Saturdays, if required. We will use noise reducing barriers where possible to help minimise any noise disruption to the local community, working as efficiently as possible whilst keeping our work areas safe and tidy.

What to expect

To ensure the safety of the public and our staff, temporary changes will be in place on Kilburn High Road and surrounding roads (shown on the following page).

During both phases there will be:

- Lane closures in place on Kilburn High Road, and directional closures on Cambridge Avenue
- Partial road closures on Oxford Road and Greville Road
- Bus stop suspensions will be in place on Cambridge Avenue and Kilburn High Road
- Parking suspensions will be in place on Coventry Close, Oxford Road and Greville Road

Clearly signed diversion routes for vehicles and pedestrians will be in place.

Parking suspensions will be in place on Coventry Close, Oxford Road and Greville Road.

Continue to monitor our working methods to reduce disruption. Dates mentioned in this notification may change. We will provide updates at www.hs2.org.uk/in-your-area/map/

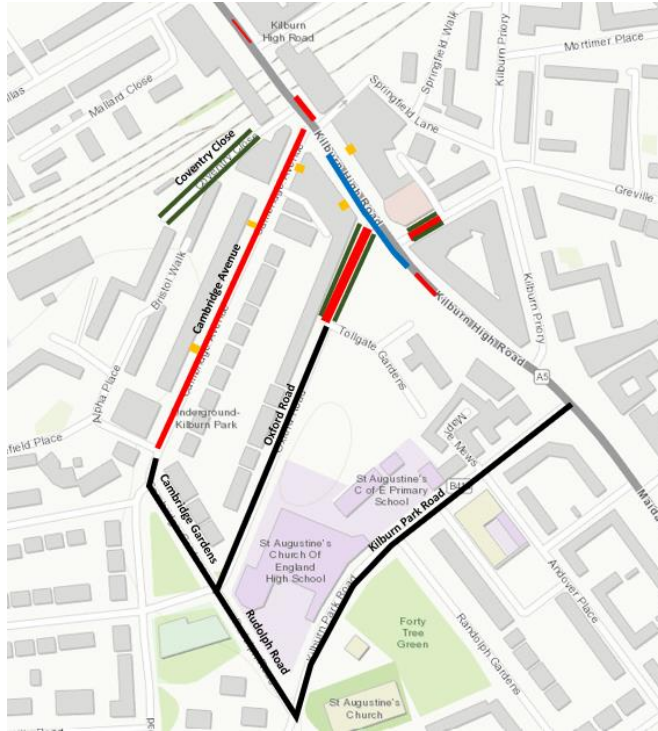

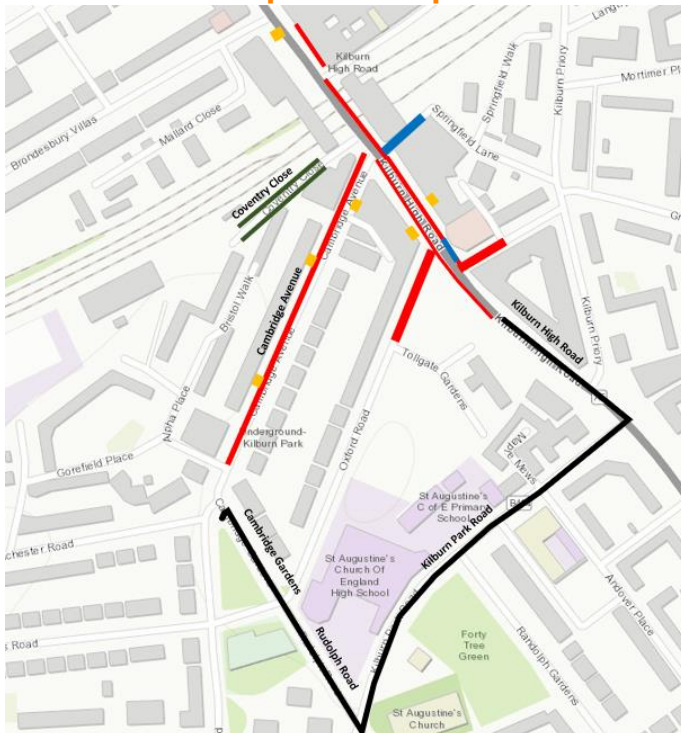
