Notice of Ground Investigation at Perivale Wood

High Speed Two (HS2) is the new high speed railway for Britain.

Ground investigations in your area

On 17 February 2023, between 8am and 5pm, we will be carrying out a series of ground investigations within Perivale Wood.

These works are taking place following discussions with Selborne Society, the national conservation organisation, responsible for the maintenance of Perivale Wood. The ground investigations will assist with future works to facilitate the construction of a wheelchair-accessible driveway.

The ground investigations will consist of digging temporary trenches on Perivale Wood's driveway to confirm the location of utilities under the ground at the entrance the reserve. We will not be working on the reserve itself and your utility services will not be affected during these works, to
