High Speed Two (HS2) is the new high speed railway for Britain.

Works planned on Brunswick Road

On Wednesday 8 and Thursday 9 March 2023, we will be carrying out a ground penetrating radar (GPR) survey on Brunswick Road between 8am and 6pm.

If required, we will carry out a further survey overnight on Friday 10 March 2023

The surveys will help us to understand the best ways to protect or divert utilities services during construction, and assist the design of the new railway.

How this might affect you

The survey will be carried out next to the allotment site behind Brunswick Road. Resident access will be maintained at all times. We will be working as efficiently as possible whilst keeping our work areas safe and tidy. You can view a map showing the location of these works below.
