



## Update: Notice of environmental works on land off Morton Lane, Colwich

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty and its appointed subcontractors are working on behalf of HS2 Ltd to carry out early environmental works between Lichfield and Crewe.

### What we are doing

As part of our early environmental works, we will establish critical environmental and species relocation sites creating new habitats for local wildlife before any main work starts.

We must plant, by hand, 180,000 tree and hedge plants along the route, and approximately 8,000 of these will be planted off Kings Bromley Lane. There is a short window of opportunity during March when we can carry out this work.

In order to do this, we will be planting on four consecutive Saturdays from 4 March to 25 March 2023. We will work between 8am and 4pm **this will be in addition to the normal working week Monday to Friday 8am to 6pm**

The planting will be carried out by hand, without machinery, so that the work will not cause any excess noise.

We will be working on:

**Saturday 18 March, Saturday 25 March**

Movement of vehicles on/off Kings Bromley Lane will be kept to a minimum.

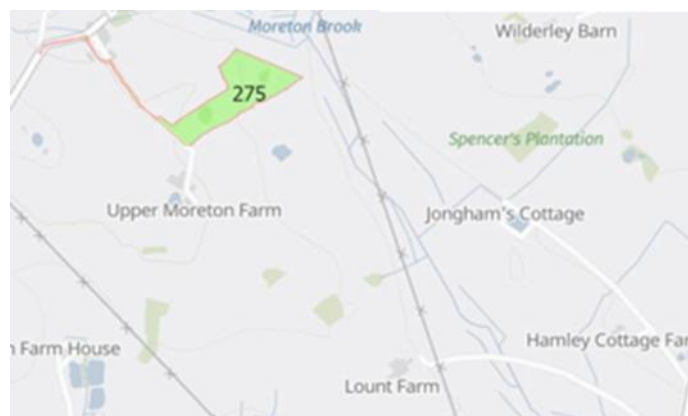
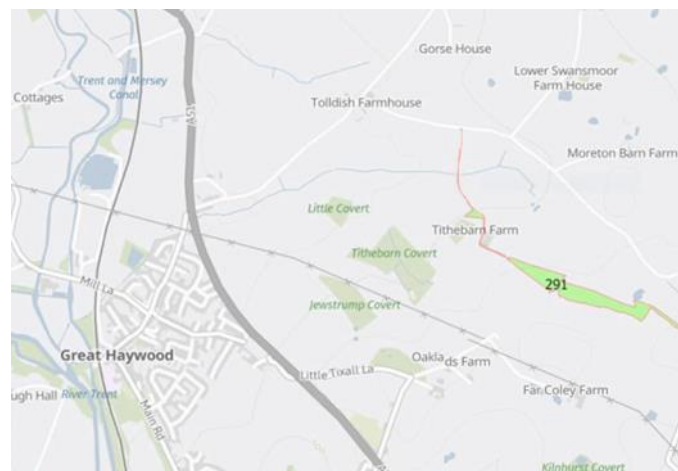

## About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
