

# Notice of overnight closures on A4097 Kingsbury Road

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

## The work we are doing

We are constructing a new roundabout, on the A4097 Kingsbury Road, to provide a safe access and egress to the Kingsbury Main Compound.

We will be undertaking works to complete the roundabout that will enable the A4097 Kingsbury Road to re-open to two way traffic on Saturday 4 March 2023. We will remove the existing lane closure and traffic management by this date allowing road users to travel in both directions along the A4097 Kingsbury Road.

We will continue to work on the entry and exit slip-roads to our compound but this will not require any traffic management.

To complete these works safely we will have three weeks of full overnight closures on the A4097 Kingsbury Road.

## When these works will take place

To enable us to complete the roundabout we will have overnight closures of the A4097 Kingsbury Road from **Monday 13 February to Friday 3 March between 9pm – 5am.**

Please follow the diversion route that will be in place (see map on page two). The daytime lane closure will be in place until completion of the works.

Some low level noise will be generated from the work we are completing.

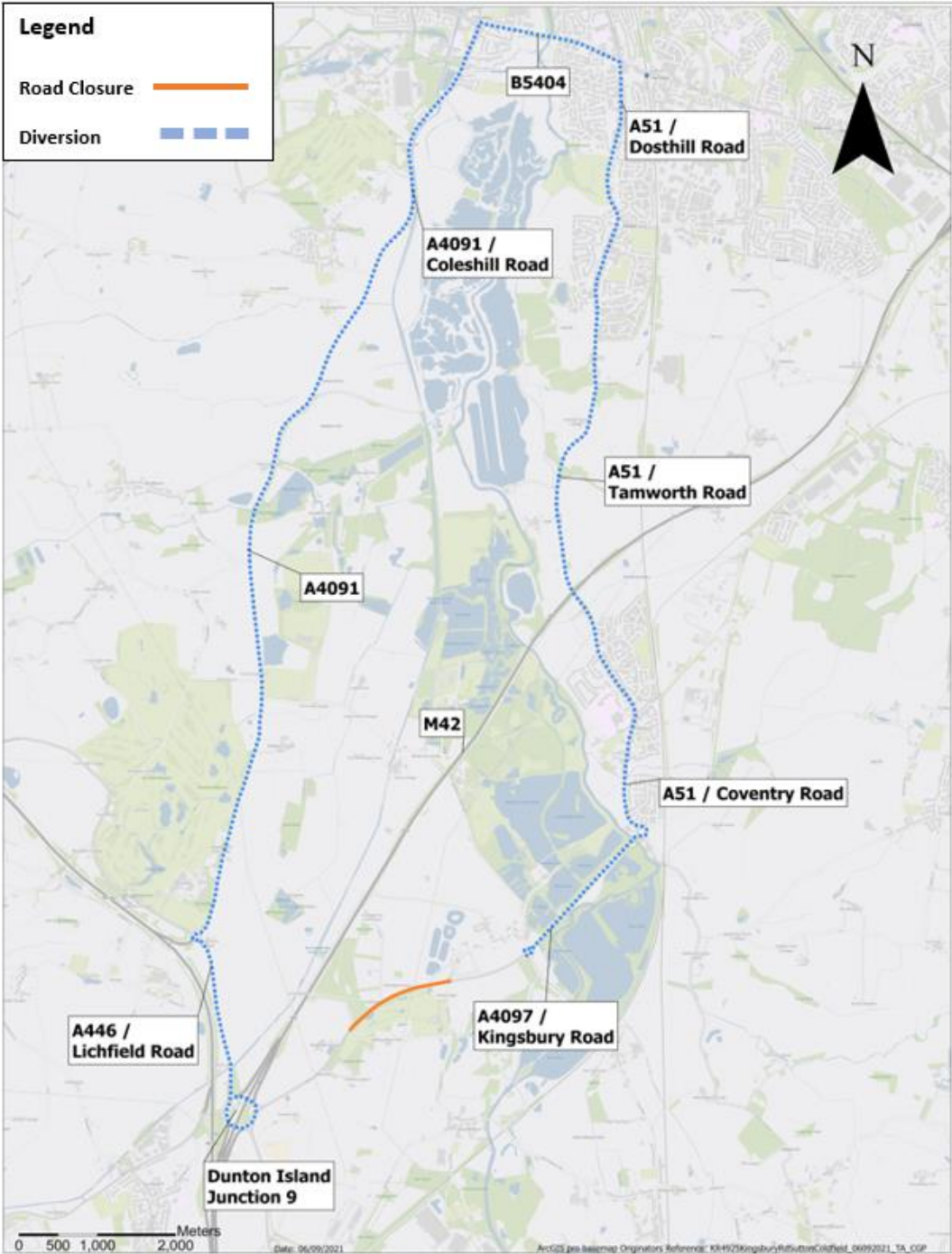
