High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We will be using a plant crossing at A429 Kenilworth Road. This will allow our vehicles to cross the road safely and reduce congestion. Through traffic will have priority over the plant crossing once complete.

The plant crossing will remain in place until the end of 2023 to enable our construction works to operate with minimal impact on local journey times in the area.

When will these works be taking place?

Plant crossing will be in operation on **A429 Kenilworth Road** from **13 February 2023 until 2023**. Our working hours will be 8am to 6pm Monday to Friday and possibly 8am to 1pm on Saturday. Outside of these hours the crossing will be switched off. Our workforce may be on site one hour before and one hour after to set up and secure our equipment.

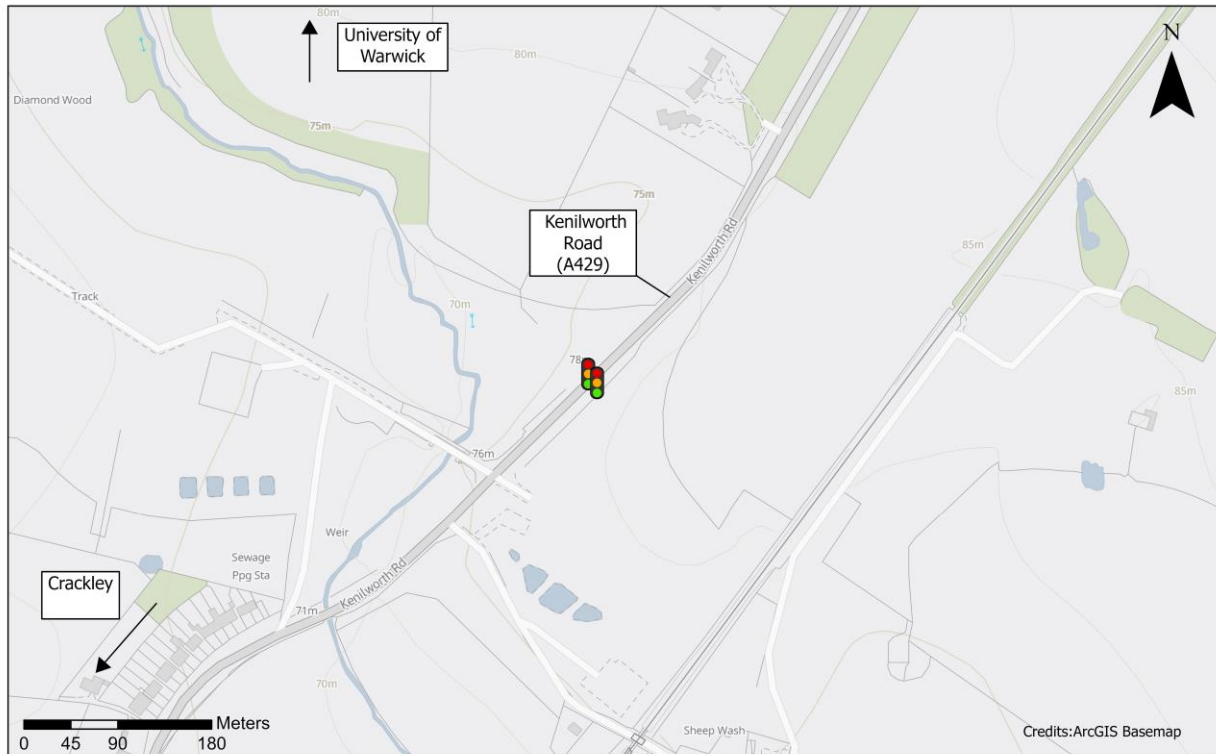
