Notice of works on **Cobourg Street**

High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

Update: New hoarding alignment on Cobourg Street (south)

We wrote to you in December 2022 to let you know that we are carrying out hoarding move works on Cobourg Street. We have now completed hoarding works at Cobourg Street (north) and are continuing to carry out works at Cobourg Street (south).

We are now extending the existing hoarding across the roadway to the edge of the western pavement to cover the worksite at Cobourg Street (south) until early March 2023. This is required to enable multi-utilities works which will be ongoing until November 2023 (subject to change). Additional lighting and CCTV will be added to the hoarding. As we install the hoarding, there will be no pedestrian access from Euston Street onto Cobourg Street between the hours of 8am to 5pm Monday to Friday. During these times, pedestrians will need to walk via North Gower Street and Drummond Street to access the station. We apologise for any inconvenience caused whilst the hoarding is being installed.

What to expect

We recognise that construction work can be disruptive to those living or working nearby. The nature of our work often means some disturbance is unavoidable, but please be assured that every effort is made to minimise any unnecessary noise. Please note that changes to the programme may occur and if these changes are likely to cause any disturbance, we will write to you again.

Works will include:

- Hoarding blocks to be put in place with use of excavator
- Traffic management will be in place and kept to a minimum
- No pedestrian access on Cobourg Street (south) between 8am to 5pm Monday to Friday as hoarding is installed
- We expect our works to be noisy at times however we will work to minimise disruption wherever possible.

Working hours

- 8am to 6pm weekdays (excluding bank holidays)
- On occasions it may be necessary to work 8am to 6pm Saturday and Sundays
- We will start-up and close-down activities up to one hour before and up to one hour after normal working hours above
- Intermittent delivery of materials to site before 7am and after 7pm for materials not permitted on London roads during the day.
