

# Update: Notice of Road closure on the Tixall Road Hoomill Lane, and Mill Lane

High Speed Two (HS2) is the new high speed railway for Britain. Kier is carrying out surveys and investigating ground conditions along the Phase 2a route.

## What we are doing

We are developing designs for junction improvement to support traffic flow. We have completed the ground penetrating radar and topographical surveys which are above ground to help inform future construction design. Our next step is to carry out surveys that involves pavement coring, bore holes, trial pits on and off the highway. We will excavate below ground to provide us with samples and allow us to view the structure and record the layout of land.

To carry out this work safely we will need to close the Tixall Road and the crossroad for Hoomill Lane, Mill Lane, the road to Ingestre. **Great Haywood.**

## When the work will take place

This work will now take place from **Monday 27 February to Friday 17 March 2023 between 9pm to 5am**. Please note that all our planned roadworks may be subject to change due to weather conditions or unforeseen circumstance.

## How will this affect you

We recognise closing a road maybe be frustrating, and by working overnight this is the safest and least disruptive way of completing our survey work. The diversion route has been chosen as a suitable route for all vehicles, please allow approximately 20 minutes for your journey during this time. We will put a signed diversion route in place on the evenings of the road closures. There may occasions we will use traffic lights to access land. This will be removed once the road closure is in place.

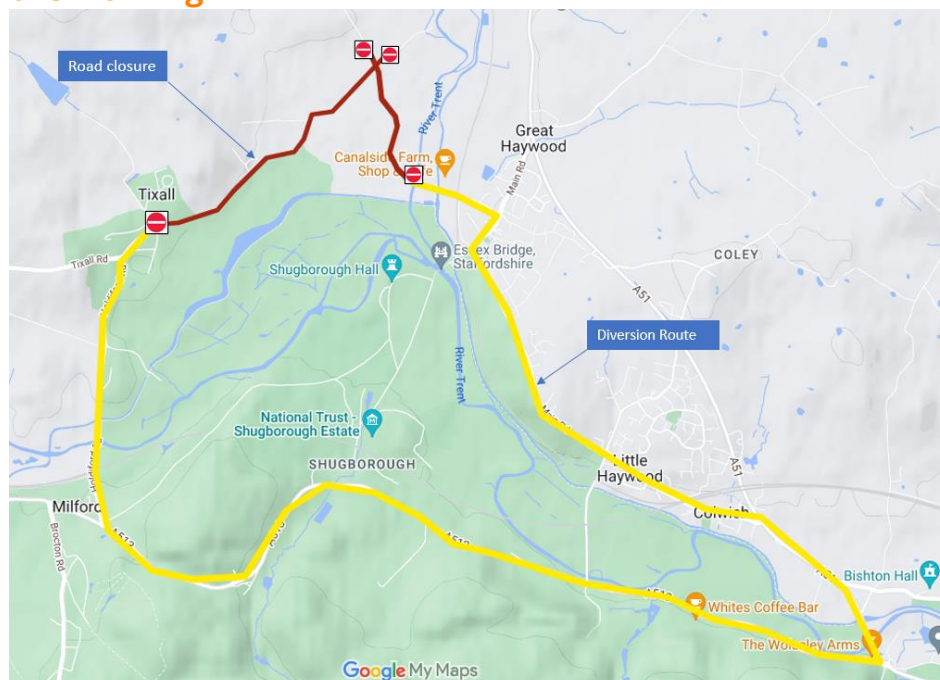
As part of the work, we will use machinery and equipment that may generate some noise throughout our time on site, we will work to reduce the impact on properties. **Escorts will be on standby to safely guild residents, business, and guests in and out of Ingestre Village when the closure is in place.**

## How we will minimise disruption

We recognise this maybe be frustrating and by working overnight this is the safest and least disruptive way of completing our survey work. We will maintain access for properties and business within the traffic management area. Please be patient while we secure the work area to guide users in and out safely. We will also carry out the following:

Reduce noise generated from our vehicles when not in use. Obtain permission from Staffordshire County Council to avoid clashes with other roadworks in the area to prevent delays. Restore work areas to their original condition and work hard to complete the work safely and as quickly as possible.
