## Notice of survey works Fradley, Lichfield

High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, the British Pipeline Agency are carrying out site surveys and assessments in the Fradley area.

### What are we doing?

Due to the HS2 railway development works, the British Pipeline Association has been asked to divert an existing pipeline in the Fradley area.

In preparation for these diversion works, during February and early March 202, we will be carrying out survey and preparation works. We will work on land to the north-west of Fradley, mostly within rural fields. The work includes excavating two trial holes and relocating sections of hedgerow.

### When will the work take place?

The work will begin on 27 February 2023 and is expected to last up to 1 week. Our working hours will be 8am to 6pm Monday to Friday.

#### How will this affect me?

As the works are **largely** within rural fields there should be minimal disruption to the local community. However, you may notice a slight increase in construction traffic while the work is ongoing.
