# Notice of works at Badminton Close – Road Closure

High Speed Two (HS2) is the new high speed railway for Britain.

## What we are doing

We have been speaking to residents about our work programme and our plan to create a secondary access road on Badminton Close.

In advance of this, we need to carry out a survey on 21 February 2023 to track underground services. The team must work in the highway to carry out detection of the services and lift manhole covers.

This work is scheduled to be completed on this one day from 10am to 3pm. An additional contingency day is allocated for 22 February if more time is needed.

The best way to undertake this (which will minimise the disruption to residents and safeguard the survey team) would be to install a full road closure whilst maintaining access for residents. We will put traffic marshals in place to manage any resident vehicle movements through the worksite. No parking suspensions will be in place.

We would like to apologise in advance for any disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum.
