



Notice of temporary closure of Brick Kiln Lane, Middleton

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

To enable the construction of the new railway we will need to divert utilities located alongside and across Brick Kiln Lane. Prior to commencing the diversion works we need to undertake surveys along Brick Kiln Lane and Bodymoor Heath Lane. This will require a temporary closure on Brick Kiln Lane with temporary traffic lights (map on page2).

When these works will take place

We will have a temporary closure of Brick Kiln Lane from Monday 27 February 2023 to Tuesday 28 February 2023, between 9.30am to 3.30pm and two-way lights on the A4091. During this closure access will be maintained for residents via Wishaw Lane.

We will have 3-way traffic lights on the A4091 and Bodymoor Heath Road on Wednesday 01 March 2023.

We will install signage on the roadside.
