High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We have created a crossing point on Rookery Lane that will allow the public and our construction vehicles to pass safely as we build the new railway. We need to activate the traffic light system and install road signage before we can make this crossing point fully operational. To complete this work, we will install a temporary closure of Rookery Lane for one day.

When the work will take place

We will complete these works on Tuesday 07 March 2023. Our working hours will be 8am to 6pm.
