

Notice of temporary hard shoulder closure on M42 motorway northbound

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.


The work we are doing

We are constructing haul roads and site accesses along the route of HS2. Haul roads are temporary roads provided within a working area to allow for the movement of construction materials, construction machinery and/or construction staff around the site.

We are creating a haul road off the A446 Lichfield Road, which will allow us to commence work on Birmingham and Fazeley Canal Viaduct. To maintain the safety of road users we will install a temporary closure of a section of hard shoulder of the M42 motorway near junction 9.

When the work will take place

We will close the section of the northbound hard shoulder (see map below) from Monday 13 March to Friday 24 March 2023 between **9.30am to 3.30pm** each day.
