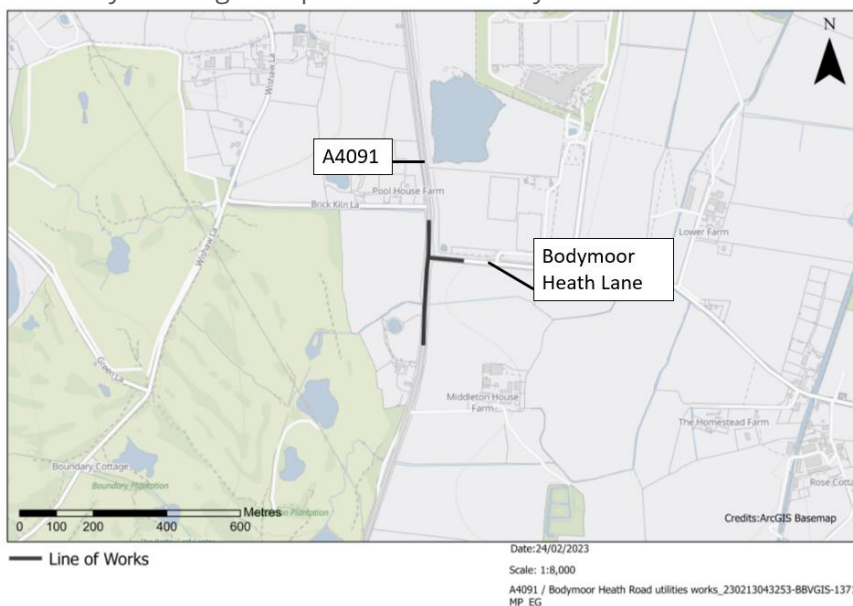
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

Before we can construct the new railway we will be diverting underground utilities along the A4091 and Bodymoor Heath Road. While we complete these works we will excavate a section of the carriageway and complete works in the verges.

When the work will take place

To carry out these works safely we will install a single lane closure on the A4091 and Bodymoor Heath Road from **Monday 13 March to Monday 17 April 2023**. During this period, we will have temporary three-way traffic lights in place 24 hours a day.

Temporary lane closures and traffic lights from Monday 13 March to Monday 17 April 2023.

Temporary traffic lights will be in place 24 hours a day.

Working hours from 8am to 6pm (Mon-Fri) and 8am to 1pm (Sat).
