



Notice of daytime lane closure on A413, Little Missenden for maintenance works

High Speed Two (HS2) is the new high speed railway for Britain. This is a notification regarding a lane closure on the A413 at Little Missenden to enable road gully maintenance.

Why are you doing these works?

Road gullies are small chambers in the roadside that allow rainwater to flow from the road surface to the underground drainage system. Some road gullies in this area have been identified as requiring immediate attention. We are working on behalf of Buckinghamshire Council to assist with these maintenance works.

What will you be doing?

Our contractors will temporarily close one lane of the A413 towards Amersham to complete a CCTV and condition survey of the road gullies and culverts.

How will this affect you?

To conduct these works safely, a temporary inside lane closure will be in place along the A413 from Chalk Lane to Keepers Lane. This section of road towards Amersham will be reduced to one lane but open to traffic at all times on:

- Tuesday 7 February from 9.30am to 3.30pm

We will reopen the roads fully as soon as we are able.

Tuesday 7 February
from 9.30am to 3.30pm

What to expect

Traffic will be managed by a daytime lane closure on the A413 outside the Little Missenden shaft site. Operatives will be working in the inside lane near the verge

What we will do

Keep the traffic flowing by closing the inside lane only at off peak times. Reopen the lane at 3.30pm or earlier if able to do so
