Notice of Public Right of Way diversion, Footpath AE28 near Chipping Warden

What are we doing?

From 1 March, we will be diverting a Public Right of Way (PROW) known as Footpath AE28, which is located near Chipping Warden, next to Culworth Road. This diversion will be in place for approximately 24 months.

We have now increased the movement of heavy plant in the area where AE28 currently crosses our construction area. We will be maintaining access to AE28 but in the interests of safety, we will be diverting the footpath.

Our diversion will take users a short distance along Culworth Road, across our highway crossing area, and reconnect to the existing footpath via a new temporary path. A map of the diversion is included overleaf.

The safety of users is paramount and further alterations of the crossing area may be required as our progress continues.

When will these works take place?

From 1 March 2023, a section of the Footpath AE28 will be temporarily diverted until the end of 2024. Signage on the footpath will indicate the diversion.


