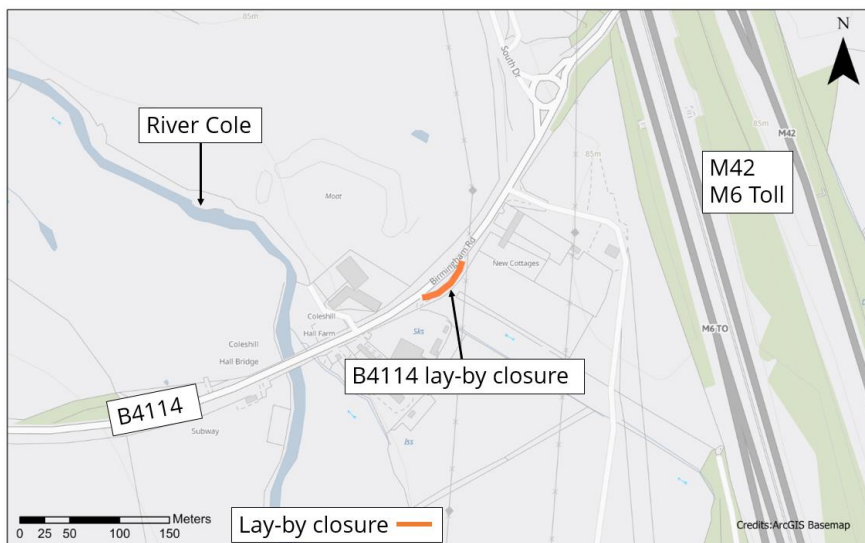

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be completing

We are continuing to prepare for works to construct the Coleshill Viaducts that will carry the HS2 railway over the existing B4114 Birmingham Road.

As part of these works, we will begin utility diversions in the lay-by on the B4114 Birmingham Road. To complete this work safely, we will install a closure to the lay-by from Monday 20 February 2023. The closure will be in place throughout the duration of our construction period.



Coleshill Drop ins

We will host drop ins at Coleshill Town Hall on Wednesday 22 February between 4.00pm and 7.00pm. The drop ins are an opportunity for you to find out more about HS2, what it means for your local area and have your questions answered.
