



## UPDATED: Notice of traffic management on Wood End Lane, Fradley

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will be doing

We have been undertaking trial hole and coring surveys on Wood End Lane on the carriageway and verges at this location (please see map below of our working area).

**While undertaking these works on Wood End Lane we have discovered a disused manhole which will require works to make it safe for road users and the public. Due to this, we will need to extend the temporary traffic lights by a further three days.**

### When the work will take place

The works will take place from Monday 06 February 2023 to Wednesday 08 February 2023. To carry out these works safely we will install temporary traffic lights on Wood End Lane from 9:30am to 3:30pm each day.
