

# Update: Utility works on Greenford Road, Ealing

## What we are doing

We wrote to you last month regarding the utility works on Greenford Road to dig two trial holes which was planned to be completed on 24 March 2023. Due to a change in the work required for the second trial hole we have delayed this work.

We will now be digging the second trial hole on Greenford Road **from 31 March to 4 April 2023** in the area shown on the map overleaf during the following times - Friday to Tuesday 8am to 6pm.

Traffic management with a reduction in lane width and additional traffic lights will be in place 24 hours a day during this time.

## How these surveys might affect you

We will be using an excavation vacuum to remove the soil during these works, and we expect that this will create some noise. However, we will be using noise reducing barriers to minimise disruption and will limit its use as much as possible.

Temporary traffic management will be in place around the works site.

We will maintain pedestrian access past the works with dedicated crossing points. There will be a clearly signed diversion route for pedestrians along Greenford Road.

We would like to apologise in advance for the disruption or inconvenience this may cause. Every effort is being taken to ensure that these works are carried out in the least impactful way. We will ensure that disruption is kept to a minimum.
