



UPDATED: Notice of temporary closure of Netherstowe Lane

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

We will be diverting underground utilities, along Netherstowe Lane and Wood End Lane, as we build the new railway. We will commence the first phase of the diversion on Netherstowe Lane, which will require the carriageway to be excavated and works completed in the verges. To ensure the safety of the public, cyclists and equestrians we will install a temporary closure of Netherstowe Lane.

When the work will take place

These works will take place between Monday 06 March to Friday 31 March 2023. The closure will be in place 24 hours each day including weekends. Our working hours are 8am to 6pm (Mon to Fri) and we may on occasion work on Saturday (8am – 1pm). The closure will remain in place over the weekends to ensure the safety of the passing public.

Access to properties and emergency services will be maintained via the Lichfield Road entrance to Netherstowe Lane.

We will also clearly signpost a local diversion route for cyclists.

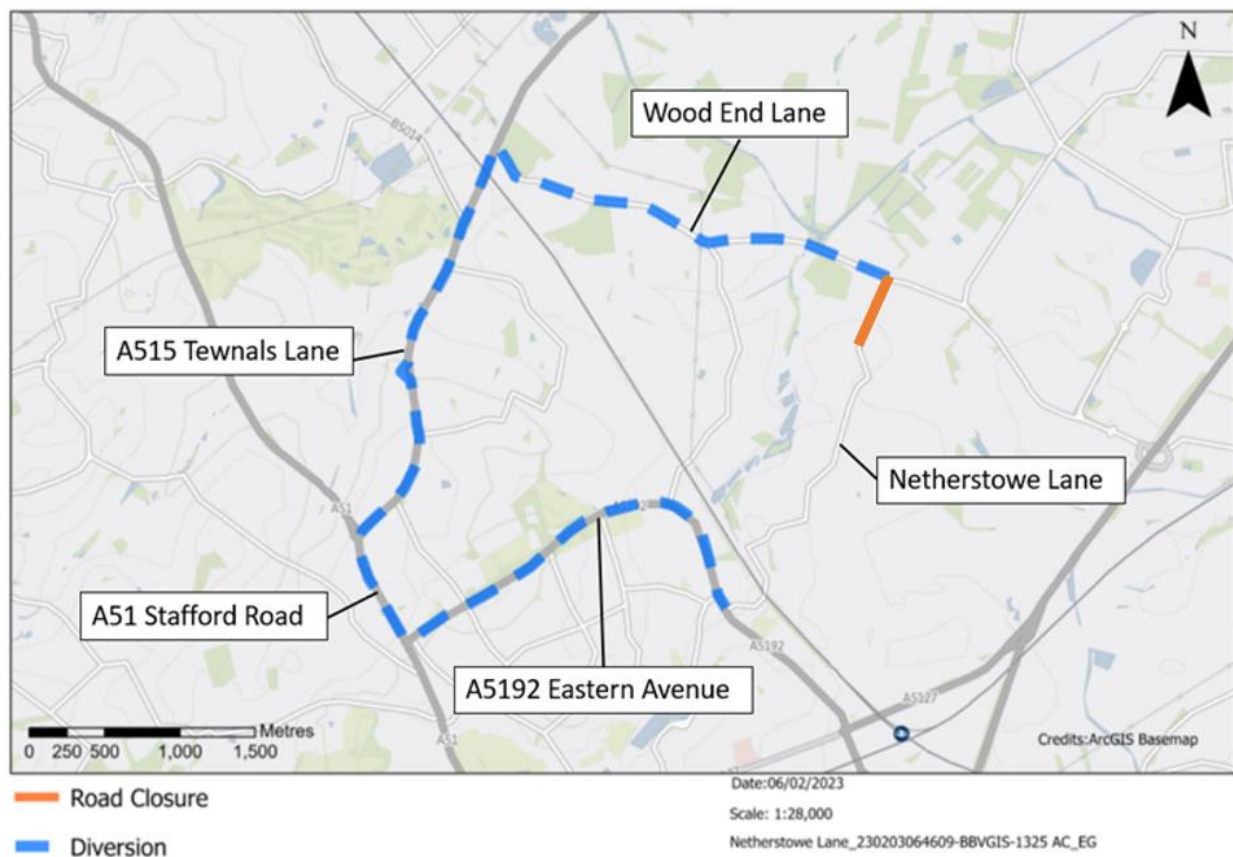

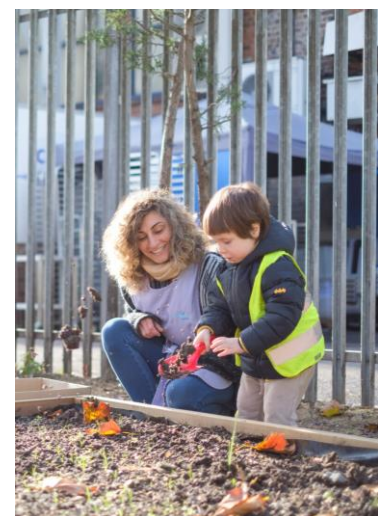
About our Community and Business Funds
