



# Notice of works on Euston Road and Churchway

High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

## Vodafone utility diversion works on Euston Road and Churchway from early March to mid-April 2023

### What are we doing?

Vodafone utility diversion works will take place on the junction of Churchway and Euston Road. The eastbound bus lane adjacent to the working areas will be closed from Churchway to Midland Road during these works. The British Library bus stop C will be suspended during the Ossulston Street and Midland Road phased works. We will always maintain two lanes of eastbound traffic.

Chalton Street junction at Euston Road will be closed throughout these works except on market days when we will remove the closure to allow access for the market traders. Entry and way out of Chalton Street will be via Phoenix Road on all other days.

Ossulston Street junction at Euston Road will be closed throughout these works. This junction will remain open for cyclists only. Entry and way out of Ossulston Street will be via Phoenix Road on all other days.

The north side footpath on Churchway will be partially closed during this phase of works. There will be a pedestrian diversion around the work area.

### When will these works take place?

From early March until mid-April, we will carry out phased Vodafone diversion works on the north side of Euston Road from Churchway to Midland Road.

### What to expect

- Suspension of the eastbound bus lane on Euston Road
- Traffic delays – please allow more time for your journey
- Traffic management, with 2m heras fencing around worksites
- Pedestrian crossings on Euston Road will remain open, with marshals in attendance at some times
- Deliveries to and removal of materials from our worksites

- From early March to mid-April 2023

### Working hours

- 8am to 6pm weekdays
- Saturdays 8am to 1pm
- Works may take place at other times

### What to expect:

- Traffic delays
- Chalton Street junction closed
- Ossulston Street junction closed
- Access to Chalton Street on market days
- Bus lane closure
- Bus stop C suspended
- Noise while breaking the road surface
- Access will be maintained from Phoenix Road

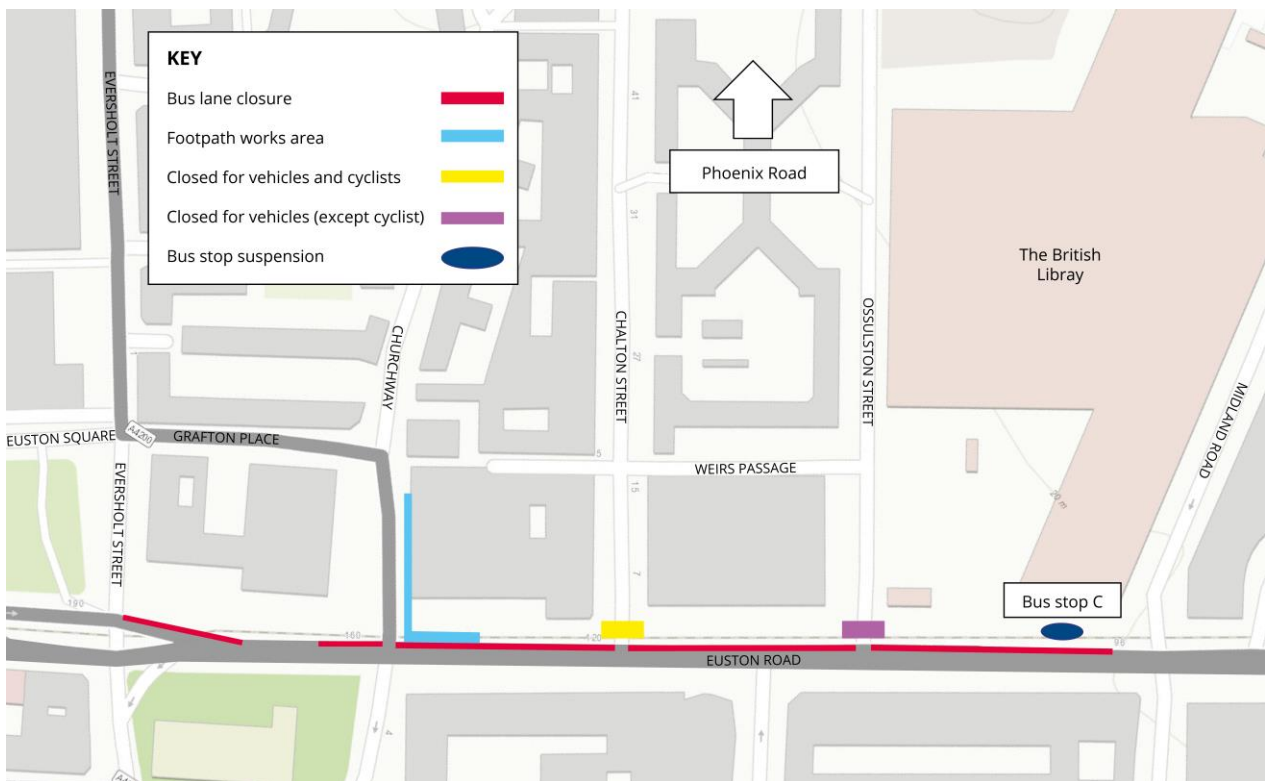
### What we will do:

## Euston Road and Churchway Vodaphone utility diversion works



We have ensured that the needs of pedestrians, cyclists and vulnerable road users are considered and addressed in the design of the temporary road layouts and crossings. Cyclists should note that road conditions will change, and lanes will be narrower. You may prefer to use alternative dedicated cycle routes to the south along Tavistock Place. We recognise that construction work can be disruptive to those living or working nearby. The nature of our work often means some disturbance is unavoidable, but every effort is made to minimise any unnecessary noise. We will closely monitor all noise, vibration, and dust levels to ensure we do not exceed our agreed limits.

### What other works are taking place in the area?

At the same time as the above works are taking place, we will be removing the central reservation on Euston Road in the area adjacent to Euston Station. We informed you about these works in our previous update (HS2-MW-MD-Ph1-EuSt-S3-Prog-works-7-27/01/202).
