High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.


The works we will do

We are constructing haul roads and site accesses within Lea Marston and Curdworth. Haul roads are temporary roads provided within a working area to allow for the movement of construction materials, construction machinery and/or construction staff around the site.

We will be creating an access to our working area off the A4097 Kingsbury Road. To maintain the safety of road users, equestrian and pedestrians, we will install a lane closure with temporary traffic lights while we complete these works.

When these works will take place

We will complete these works from **Monday 27 March to Friday 31 March 2023** between **8am to 6pm**. The temporary traffic lights will be in place 24 hours per day during this period and the temporary traffic lights will be marshalled during peak hours.
